Extension Requests

DEAR MS. DORTCH,

Lowcountry 34 Media, LLC (“Lowcountry”) is the proposed assignee for the 39 low-power television station construction permits listed in the attached chart (“LPTV Permits”), each of which has pending a request for extension (“Extension Request”).

Lowcountry fully intends that each of the LPTV Permits will be constructed in accordance either with the July 2021 deadline for construction or the extended deadline if granted pursuant to the corresponding LPTV Permit’s Extension Request. Lowcountry is working on behalf of, and under the direction and supervision of the current permittees, Landover 2 LLC and CTB Spectrum Services Two LLC, to construct certain of the LPTV Permits on or before the assignment application (“Assignment Application”) is granted (obviating the need for the relevant Extension Requests, if construction goes as scheduled).

For the other LPTV Permits, Lowcountry fully intends to complete construction of the LPTV Permits following consummation of the Assignment Application: (1) in accordance with the timeline for construction set forth in the LPTV Permit’s Extension Request; and (2) prior to the LPTV Permit’s expiration date – as may be extended pursuant to its Extension Request.
