AMENDMENT TO APPLICATIONS FOR RELICENSING OF KWNE AND KMKX.

This statement is response to questions about **Public Inspection File** postings for KWNE, Ukiah, CA (Fac 7087). This response also applies to the application by Radio Millennium LLC of KMKX, Willits, CA (Fac 65699) which is under L M A agreement with Broadcasting Corporation of Mendocino County.

Our stations' commitments addressing local issues are robust with local news broadcast 13 times each weekday, extensive PSAs and sponsorships of local nonprofit endeavors. However, we are now carefully correcting our public file posting procedures.

Of our staff of four, our Office Manager had responsibility for posting material to our public file and was instructed to upload all documents from our web site to the FCC site by 2018. Instead, on her own, she reinterpreted FCC instructions as only requiring uploading new material after March of 2018 and leaving previous posted material on our own web sites. She also missed some filing deadlines of News Story Logs and PSA Logs with explanations about reports needing revision for accuracy or internet issues.

The one page Issues and Programs list with codes to relate them to news stories was posted in 2018 however it was also elsewhere on our web page earlier.

She incorrectly reported to the stations' general manager and owners/licensees that the stations were in compliance.

This individual is no longer with our company.

All the public file material has been complete and available to the public on time or within only a few days afterward. A link directing visitors to the FCC website has been on our site since early 2018 and is there now.

Our new Office Manager has been carefully trained and is being monitored In her learning period. She uploaded some news logs to “additional documents” instead of “Issues “ subfile for Q4 2020 and Q1 2021. She then responsibly opened a help ticket with the FCC (896655) to learn and correct her error.

Items regarding **Ownership Reports** for clarity:

On advice by phone with FCC , ownership was reported as unchanged by letter in 2015. There have been no ownership changes during the 8 year license period.

There was some undetermined irregularity in trying several times to efile our forms 323 during October 2017 in making them show up in the FCC database. The final attempt to get the filings to show was on 1/17/2018. We then scanned and posted the “Reference Copy” of the 323s on our own web sites’ public files for the record. It is in “Other Documents”.

Other 323 filings were normal.

Political Records for one County Supervisor’s campaign advertising schedule was posted late because they were misfiled by a parttime employee and had to be recovered after an exhaustive search.

We now believe that all requisite filings are now completely uploaded and in place on the FCC’s on line Public Information File database. We have been told so recently on phone by FCC staff.

The General Manager has reviewed the reporting and public file requirements with station staff and has taken steps to ensure that future public file documents will be properly filed and timely uploaded to appropriate FCC-hosted public files.
