ALL STEPS TAKEN BY K45IM-D TO COMPLETE CONSTRUCTION
SINCE THE GRANT OF DISPLACEMENT APPLICATION IN JUNE 2018

INTRODUCTION

The following is an executive summary of the steps taken by K45IM to begin broadcasting again. We incurred and paid a large amount of expenses converting from analog to digital operation and was beginning to identify sales revenue before the T-Mobile purchase. T-Mobile later sent us a notification ordering us to cease operations. We were instructed to contact the FCC which we did and were notified of the right to file a displacement application. We were not informed of the requirement to file an STA application until Andrew Kennedy email. Since we had depleted our financial resources and T-Mobile refused to fund the reconstruction, we decided to wait and participate in the FCC Reimbursement program. The FCC approved our eligibility and has funded a very large part of our budget. We have also contracted with Simultv. to provide broadcasting equipment and programming for the station. Initially we were attempting to secure an extension of the construction permit prior to expiration. However, our goal now is to complete construction prior to the construction expiration day. The outline below shows that we have worked in good faith to complete construction and begin operating. We hereby request your consideration in allowing us to complete the process.
