Dear Mr. Wilson:

We are writing to you on behalf of Developers & Managers Group, LLC ("Developers & Managers Group"). Developers & Managers is the owner of the following FCC low power digital television stations: K38NR-D, K45IY, and K45IM-D.

Developers & Managers Group is an African American company located in Baton Rouge, LA. Over the past few years Developers & Managers Group has invested over \$150,000 to purchase and convert the stations from analog to digital. The money was borrowed from the Louisiana Community Development Capital Fund, Inc. ("Capfund") an African American financial institution licensed by the United States Department of the Treasury CDFI Fund.

Developers & Managers Group has received two letters of notification from T-Mobile dated April 27, 2018 and May 10, 2018 informing the Company that T-Mobile is preparing to commence operations on its 600MHz spectrum in the Partial Economic Area ("PEA") #189 by 9/7/2018 and K38NR-D, K45IY, K45IM-D are likely to cause harmful interference to T-Mobile's operations.

The letter states that FCC regulations require Developers & Managers Group to cease operations or eliminate the potential for harmful interference to T-Mobile's wireless facilities in the PEA# 189 market. The letter further states that the FCC will work with the Company.

Enclosed with your letter of notification was a letter dated July 17, 2017 from Steve B. Sharkey, Vice President, Government Affairs, Technology and Engineering Policy, T-Mobile USA, Inc. (202) 654-5900 addressed to Ms.

Marlene H. Dortch, Secretary, Federal Communications Commission, 445 12th Street, S.W., Room TW-A325, Washington, D.C. 20554. In the letter, Mr. Sharkey informs the FCC of a voluntary commitment that T-Mobile USA, Inc. ("T-Mobile") is making to compensate certain low power television stations that operate on a secondary basis and are unable to obtain a permanent channel in time to accommodate T-Mobile's rapid deployment of broadband service in the 600 MHz band.

We have called Mr. Sharkey several times and left messages for him to return our telephone calls with no response to date. We have talked to Mr. Hossein at the FCC about the options available. He has suggested that we retained a consulting engineer to perform a search.

Developers & Managers Group's financial resources have been depleted during the process of converting the stations from analog to digital. Unless your company provides assistance, we will have no other alternative than to cease operations.

Therefore, please accept this letter as a written request to T-Mobile from Developers & Managers Group to coordinate our operations by providing financial and/or technical assistance in identifying other frequencies in the area and the cost of moving to the new locations.

Good Morning:

The correct call sign for Alexandria is K38NR-D.

The only channels that we can recommend for these two facilities are channel 29 for K45RM-D and channel 4 for K38NR-D. However, there might be other channels available if using lower power or different antenna and how far up in the tower the antenna is installed (RCAGL). I would recommend for you to consult with an engineer and have them to look to see if other channels are possibilities. When you figured out what channels you will be using, then you have to file displacement applications for these using our e-filing system and after filing the displacement applications, then you have to file legal special temporary authority requests to start broadcasting on the new channels. Let me know if any question.

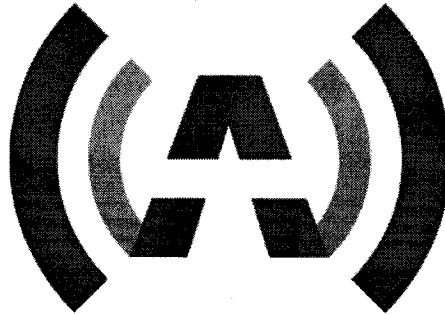

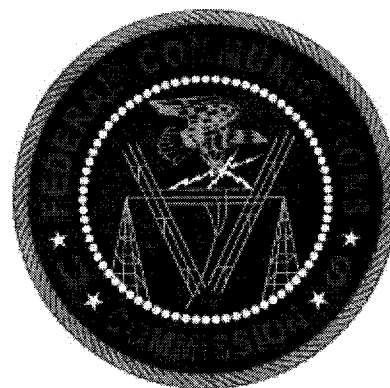

Please see below next steps in order to proceed with your 399 applications. To be fair to all clients, the provided deadlines in red will allow us enough time to parse the data, ask questions, and input the 399 before the extended 11/14 FCC deadline. We will need the below for each station.

1. "Emergency 399 Intake form": DUE 11/7/19

- a. Attached is our "Emergency 399" Intake Form which documents the original, interim (if applicable), and proposed final configuration. **Please have your contact complete every field on the form (N/A if not applicable).** Please note that engineering justification will be required when requesting a line change or TPO increase as the FCC might consider that an "upgrade". If there are any potential "red flags" in the form responses, we will need to set up a call with your in-field technical contact and the contract engineer to discuss associated risks. The accuracy and completeness of the Intake form is critical to the FCC Form 399 submittal and reimbursement. **Important note: The FCC will only reimburse a comparable configuration to the original equipment.**

2. Form 399 Eligibility requirements (please email each of the below for Anywave to prepare and submit):
DUE 11/7/19

- a. Evidence that the station was transmitting for at least 9 of 12 months for at least 2 hours per day, and not less than 28 hours per calendar week between April 12, 2016 and April 13, 2017 (submit as many of the below as possible):

- i. **Master control automation system logs (referencing the station)**
- ii. **Programming/operating logs, transmission logs (referencing the station)**
- iii. **Commercial logs (referencing the station)**
- iv. **Program guides (referencing the station and including indication that the programs listed were aired);**
- v. **Tower/facility rental/leasing agreement (specifying site location)**
- vi. **Broadcast agreement**
- vii. **Third-party affidavits (Examples might include advertisers, content providers, Electronic Program Guide (EPG) services, or, in the case of translators, associated stations. The supplying third party should explicitly affirm the affiant's first-hand knowledge of the station's operations and that it met the minimum**

- b. After submission, an email will be sent to station and station will have 10 days to confirm banking info is accurate.
- c. No reimbursement payment will be made if the bank account information in the CIAFM is not verified.
- 3. Submittal info: DUE 11/7/19
 - a. FRN and password for LMS
 - b. Reimbursement contact information (if different than applicant info)
 - c. Quotes for any equipment already purchased or planning on being purchased.
- 4. Certify 399 ready for submittal: DUE 11/11/19
 - a. After we receive all necessary data and prepare the 399 submittal, we will review with station contact to ensure accuracy.
 - b. Station can then enter LMS and click "Certify and Submit" for both the 399 Reimbursement Form and Eligibility Form.
