Mr. Johnson,

Yes, you can keep your allocation for the new channel, with a few caveats. At this point, you should revise your estimates – please go back to your Form 399 and change any aspects that are now different given the new channel or location. This may result in a different estimated total cost for your project. Whether it does or not, please be mindful that receipts or invoices which do not match the plan previously submitted will not be paid.

While this new estimate may be higher or lower than your current estimate, your current allocation will remain in place until the Commission does a “true-up” of allocations to match stations’ revisions of their plans. This typically happens quarterly. During this time, you are free to drawn down against your current allocation, assuming your estimates are up to date and match the invoices being provided.

Please continue your existing Form 399. This will ensure the Fund Administrator can see the changes being made and compare their prior analysis to the current submission.

The channel being displayed in your Form 399 will not change automatically. While this has no bearing on your ability to claim costs (unless you need access to special categories related to moving to Channel 14, or have switched between UHF and VHF), it will make analyzing the Form 399 easier. Please let me know the File Numbers of your Form 399's, and the new channels you have been assigned, and I will have them updated.

Thank you for the email. All these renewal applications were filed late so they only recently came off public notice. They are currently in processing. Under FCC rules once a renewal application is filed the license expiration date tolls until we take action on the application.

I took a quick look at the applications and to speed processing you should provide the following amendments:

- K45IM-D, 70101 –
  - This renewal application certifies the station is off the air. But, there is no silent authority that was filed in LMS.
    - If during the license term the station was ever silent for more than 30 days, amend the application to include an attachment stating all dates of silence that exceeded 30 days. 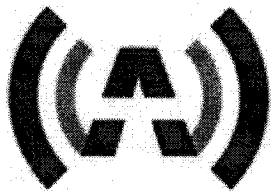
