RE: Analog Station License and Digital
Construction Permit Cancellations

Dear Licensee:

This is with respect to the former stations listed in the attached Appendix. Section 74.731(m) of the Commission's rules provides that:

After 11:59 p.m. local time, [[July 13, 2021], low power television and TV translator stations may no longer operate any facility in analog (NTSC) mode and all licenses for such analog operations shall automatically cancel at that time without any affirmative action by the Commission.¹

Commission records indicate that while you were granted a digital construction permit for each of the stations, you failed to file a license to cover by their expiration date.² As such, the stations construction permits were automatically forfeited and their license automatically cancelled at 12:00 A.M. (local time) on July 14, 2021.

Accordingly, pursuant to sections 74.788(b) and 74.731(m) of the Commission's rules,³ the construction permits and licenses for the stations listed in the Appendix were **AUTOMATICALLY FORFEITED/CANCELED** and their call signs have been **DELETED**.⁴ All authority to operate the stations has been **TERMINATED**⁵ and any operation of these facilities **MUST CEASE IMMEDIATELY**.⁶
