

Section 73.3555(a) Multiple Ownership

WGUL-FM, Inc. is modifying the license of WXZC, Channel 282C3 (104.3 MHz), Facility ID No. 71585, Inglis, Florida and as such compliance with the Commission's Section 73.3555 Multiple Ownership Rules is required. The applicant has a cognizable interest in stations in the Gainesville-Ocala Nielsen Audio Metro. Therefore a copy of the FCC Geographic Market Definition Report for Gainesville-Ocala, Florida is included in this exhibit.

WXCZ(FM), WXOF(FM) and WXZC(FM) are designated as home to the Gainesville-Ocala, FL Nielsen Radio Metro.

WGHR(FM) and WXCZ(FM) are designated as home to the Tampa/St. Petersburg/Clearwater, FL Nielsen Radio Metro. WGHR(FM) does not have overlapping principal community contours with WXZC(FM).

Gainesville-Ocala, FL Nielsen Audio Metro

The Gainesville-Ocala, FL Nielsen Audio Metro has 41 commercial and non-commercial educational full power radio stations. According to the FCC's local ownership tiers, in a metro reported by BIA as having between 30 and 44 commercial and non-commercial educational full power radio stations, a party may have a cognizable interest in up to seven commercial full power radio stations, not more than four of which are in the same service (AM or FM).

This application complies with the local radio ownership portion of the multiple ownership rules set forth in 47 CFR 73.3555(a)(ii) because only three full power radio stations, three FM stations will be cognizable to the application.

Non-Nielsen Audio Metro Designated Market

The applicant also has a cognizable interest in one FM station, WXCW, Homosassa Springs, FL which has overlapping principal community contours with WXZC and is not designated as being home to the Gainesville-Ocala Nielsen Audio Metro. Therefore an additional Non-Nielsen Audio Metro contour based ownership compliance study is included with this exhibit.

A total of 13 stations, one AM station and 12 FM stations make up the Defined Radio Market for a total of 13 stations. This includes the three subject stations that comprise the Radio Market Boundary and 10 other AM and FM stations. This does not include two FM stations, WGHR and WXCZ, which are cognizable to WGUL and are not subject stations.

Section 73.3555(a)(iii) states that in a radio market with less than 15 (inclusive) full power, commercial and noncommercial radio stations, a person or single entity (or entities under common control) may have a cognizable interest in, not more than 6 commercial radio stations in total and not more than 3 commercial stations in the same service (AM or FM), provided, however, that no person or single entity (or entities under common control) may have a cognizable interest in more than 50% of the full-power, commercial and noncommercial radio stations in such market unless the combination of stations comprises not more than one AM and one FM station. WGUL will have a cognizable interest in three FM stations. The ownership of three FM stations represents 23.1 percent of the full power, commercial and non-commercial radio stations in the Defined Market. Therefore it is believed that the proposed acquisition of WXZC is in compliance with Section 73.3555(a)(iii) of the Commission's rules for the defined radio market.

All data relating to AM or FM facilities in the relevant BIA/Nielsen market was determined using the BIA Financial Network, Inc., Media Access Pro Version 4.61. We assume no liability for errors or omissions in that database or program which may be adverse to the information contained herein.

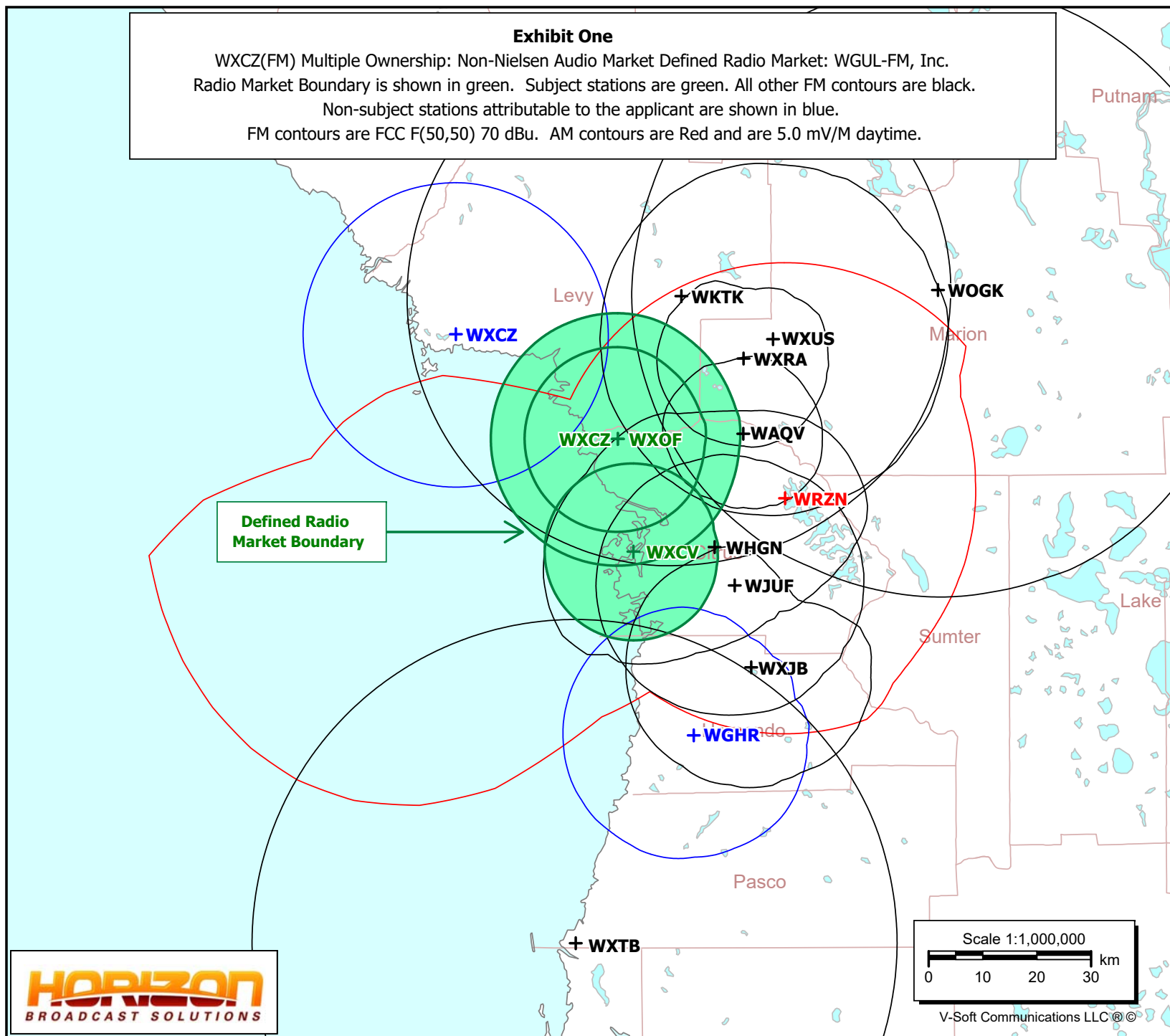
