

## TOLLING JUSTIFICATION

W45DJ-D was subject to displacement. See W30EC-D, LMS File No. 0000123144 (Copy attached). The permit specifies an expiration date of August 12, 2021.

Also attached is an April 7, 2021 invoice from Alive Telecom with respect to the antenna to be utilized with W30EC-D.

Finally, also attached is an August 10, 2021 letter from Daniel Barton, President, Alive Telecom. Mr. Barton states in his letter that the delay was occasioned by the death of Bryan Baker and, as a result, there was a disconnect. Mr. Baker was employed by Broadway Communications LLC ("BC").

BC is committed to implementing the construction permit within the time period requested.

The permittee had requested that the CP be extended. An extension request was filed on August 12, 2021. Commission staff personnel requested that a request for tolling be filed. Thus, to the extent required, it is requested that a waiver of the timeliness requirement be granted.

It is submitted that tolling is appropriate to allow the finalization of construction which would bring a new service to Panama City, Florida. The failure to complete construction was due to the death of key personnel, something clearly beyond the control of the permittee.


