Re: Applications for Extension of
Construction Permits for Digital
Low Power Television Stations¹

Dear Permittee,

This concerns the above-referenced applications for extension of time to complete construction of digital low power television stations. For the reasons stated below, the applications are dismissed.

Applications for extension of construction permit may only be filed for: (1) digital construction permits held by analog low power television and television translator stations (LPTV/translator stations) transitioning to digital; and (2) construction permits for new digital LPTV/translator stations assigned a construction permit expiration date of July 13, 2021.² Applications for extension may not be filed to extend construction permits to modify already licensed digital LPTV/translator stations or construction permits for analog-to-digital or digital-to-digital replacement translators.³ Because your construction permits do not fall into either of the two eligible categories, you may not seek extensions. If additional time is required to complete construction of your facilities, you may submit a request pursuant to the Commission's "tolling" rule.⁴

² Construction permits for new digital LPTV/translator stations granted before the December 17, 2015 release of the Commission LPTV DTV Third R&O were assigned an expiration date of July 13, 2021 – the Commission's LPTV digital transition deadline. *See* 47 CFR § 74.788(a); *see also Amendment of Parts 73 and 74 of the Commission's Rules to Establish Rules for Digital Low Power Television and Television Translator Stations, MB Docket No. 03-185*, Third Report and Order and Fourth Notice of Proposed Rulemaking, 30 FCC Rcd 14927, 14935, para. 16 (2015). Construction permits for new digital LPTV/translator stations granted after December 17, 2015, were assigned an expiration date of the later of either July 13, 2021 or three years from the date of issuance of the original construction permit. *See* 47 CFR § 74.788(a). Pursuant to section 74.788(c)(3) of the rules, permittees for new digital LPTV/translator stations with July 13, 2021 expiration dates were afforded one last opportunity to seek an extension of their digital construction permits, of not more than 180 days. *See* 47 CFR § 74.788(c)(3).

⁴ *See* 47 CFR § 73.3598(b). The tolling rule provides that a construction permit deadline may be tolled only for specific circumstances not under the licensee's control, such as acts of God or delays due to administrative or judicial review. *Id.* Stations may also seek a waiver of the tolling rule to receive additional time to construct in the case where "rare or exceptional circumstances" prevent construction, following the instructions for requesting tolling in the Appendix. *See 1998 Regulatory Review - Streamlining of Mass Media Applications, Rules and Processes*, Memorandum Opinion and Order, 14 FCC Rcd 17525, 17536, para. 42 (1999).

The above facts considered, your applications for extension of construction permits **ARE DISMISSED.**
