

AGREEMENT FOR ASSIGNMENT OF SHARES
AND STOCK POWER

THIS AGREEMENT made this day of June __, 2021, effective as of June 30, 2021, between Carl W. Wilson, and Sarah Jane Williams.

Shareholder Carl W. Wilson currently owns 33.395 of the 42.50 issued and outstanding Shares of common stock of Grants Pass Broadcasting Corporation. The shares are represented by Certificate Numbers 3,7,15,19,21,26,29,34 and 38.

Shareholder Sarah Jane Williams currently owns 9.105 of the 42.50 issued and outstanding Shares of common stock of Grants Pass Broadcasting Corporation. The shares are represented by Certificate Number 39.

Sarah Jane Williams hereby assigns and transfers all her right, title, and interest in the 9.105 shares of common stock of Grants Pass Broadcasting Corporation to Carl W. Wilson, as of June 1, 2021, and Carl W. Wilson accepts the assignment and agrees to hold Sarah Jane Williams harmless from any liabilities and obligations of Grants Pass Broadcasting Corporation. There will be no monetary consideration for the assignment. The assignment is a gift.

Sarah Jane Williams acknowledges that she will not be entitled to dividends paid or payable after May 31, 2021, and that she will not be paid out of her outstanding capital account.

Sarah Jane Williams agrees that she is solely responsible for any and all taxes or other obligations resulting from this assignment and agrees to indemnify Carl W. Wilson for any liability resulting therefrom.

This assignment requires FCC approval. Promptly upon the execution of this agreement, Grants Pass Broadcasting Corporation, Inc. will apply for approval of the ownership change. The process is expected to require approximately 75 days to complete. Upon FCC approval, Sarah Jane Williams will execute any additional documentation required to make the assignment effective.


Sarah Jane Williams represents and warrants that she is the sole owner of 9.105 shares of common stock of the Grants Pass Broadcasting, and that all of these shares are free and clear of liens or encumbrances of any kind. Sarah Jane Williams warrants to defend the title thereto against the lawful claims and demands of all persons whomsoever and warrants that there are no options, warrants or commitments of any nature vested in any other party. Sarah Jane Williams has the full right, power, authority and capacity to sell, transfer and deliver the common stock in accordance with the terms of this agreement.

Sarah Jane Williams does hereby appoint Deborah L. Sorenson as attorney to transfer the 9.105 shares of common stock of the Grants Pass Broadcasting to Carl W. Wilson, with full power of substitution in the premises.

This agreement and all documents to be executed simultaneously herewith contain the sole and entire agreement and understanding of the parties with respect to the entire subject matter hereof. Any and all prior discussions, negotiations, commitments, and understandings relating thereto are merged herein and with the documents simultaneously executed this date.

This agreement shall be binding upon and inure to the benefit of the respective parties and their successors and assigns, heirs and personal representatives.
