Explanation:

Online Public File – KTUH was informed on 03/11/2019 that it hadn't transitioned its public file to the online public file, i.e. that materials were not uploaded online (see attached). KTUH complied with the notice by uploading the required documents by 03/19/2019.

Biennial Ownership Report - KTUH did not file the biennial ownership report in 2017 and filed the report on 08/06/2018 as soon as it was aware about the late filing. In addition, KTUH previously filed the wrong Form 323 for Commercial Broadcast Stations and not Form 323-E for Non-commercial Educational Broadcast Stations. Subsequent to 2018 and 2019, the correct Form 323-E was filed.
