


**Established Local Applicant
Kulshan Community Media**



Kulshan Community Media was formally incorporated in Washington State, with an effective date of 4/04/2018, as demonstrated by the attached Articles of Incorporation, as downloaded from the website of the Washington State Office of the Secretary of State, Corporations and Charities Division.

Ever since that time, Kulshan has operated from its headquarters at 103 E Holly Street, Suite B4, in Bellingham, Washington. This address is listed on the corporation's annual report dated 5/15/2019 (copy attached). These physical headquarters are located within the proposed community of license, and (as demonstrated by the attached map exhibit) only 0.8 miles from the reference coordinates of the proposed community of license. This is well within the required 25 miles to qualify as an established local applicant.

This affirmatively demonstrates that Kulshan has, for at least the 24 months immediately prior to application, and continuing through the present, qualified as a local applicant pursuant to 47 CFR Section 73.7000. Kulshan pledges to maintain localism characteristics during the period from grant of the construction permit until the station has achieved at least four years of on-air operations.

ARTICLES OF INCORPORATION
OF
KULSHAN COMMUNITY MEDIA

The undersigned, acting as an incorporator under the Washington Nonprofit Corporation Act (Revised Code of Washington 24.03) hereby adopts and executes the following Articles of Incorporation.

ARTICLE I
Name

The name of this corporation is: Kulshan Community Media.

ARTICLE II
Duration

The period of duration of this corporation shall be perpetual.

ARTICLE III
Purposes

The purposes for which this corporation, a nonprofit charitable organization, is formed are:

1. To provide a voice reflecting the diversity of the Whatcom County community;
and
2. To expand our broadcasting to emerging media channels, including but not limited to visual, digital and internet broadcasting in order to give a broader voice to our local community; and
3. To engage in any other lawful activity which may hereafter be authorized from time to time by the Board of Directors; provided, however, that the purposes for which the corporation is formed shall at all times be consistent with Section 501(c)(3) of the Internal Revenue Code of 1986, as it now exists or as hereafter amended (the "Code"), that said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV
Powers

This corporation shall have the power to do all lawful acts or things necessary, appropriate, or desirable to carry out and in furtherance of its purposes described in Article III which are consistent with the Washington Nonprofit Corporation Act and Section 501(c)(3) of the Code.

ARTICLE V
Influence Legislation

No substantial part of the activities of this corporation shall be devoted to attempting to influence legislation by propaganda or otherwise, and the corporation shall not participate in, or intervene in (including the publication or distribution of statements with respect to) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE VI
Registered Office

The name and address of the registered agent and office of this corporation is BD Services Corporation, 300 N Commercial Street, Bellingham, Washington 98225. The written consent of such person to serve as registered agent is attached hereto.

ARTICLE VII
Board of Directors

The management of this corporation shall be vested in a Board of Directors. The number of directors, and the method of selecting directors, shall be fixed by the Bylaws of this corporation; provided, that the initial directors shall be five (5) in number and their names and addresses are:

The initial directors shall serve until the first organizational meeting of the Board of Directors and until their successors are appointed and qualified.

ARTICLE VIII
Director Liability

No director shall have personal liability to the corporation for monetary damages for conduct as a director; provided that this provision shall not eliminate the liability of a director for acts or omissions that involve intentional misconduct by a director or a knowing violation of law by a director, or for any transaction from which the director will personally receive a benefit in money, property or services to which the director is not legally entitled.

ARTICLE IX
Bylaws

The Board of Directors is authorized to make, alter, amend, or repeal the Bylaws of this corporation.

ARTICLE X
Limitations

This corporation shall have no capital stock and no part of the net earnings of this corporation shall inure in whole or in part to the benefit of, or be distributable to, any officer, director, or other individual having a personal or private interest in the activities of the corporation, or to any person or organization other than an organization which is exempt from federal income taxation under Sections 501(a) and 501(c)(3) of the Code, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, to make reimbursement for reasonable expenses incurred in its behalf, and to make payments and distributions in furtherance of the purposes stated in Article III. Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Code or (b) by a corporation the contributions to which are deductible under Section 170(c)(2) of the Code.

ARTICLE XI
Distributions upon Dissolution

On the dissolution of the corporation, any remaining assets shall be distributed to organizations qualified as exempt under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, (i) as determined by a majority of the then-serving directors, or (ii) to any governmental entity, or (iii) as determined by the court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XII
Amendments

This corporation reserves the right to amend, alter, change, or repeal any provision contained in these Articles of Incorporation by the affirmative vote of a majority of the directors' present at a meeting of the Board of Directors.

ARTICLE XIII
No Members

The corporation shall have no members.


