

\*Discrepancies exist in the wording of §73.7003(b)(2), which indicates use of a standard 3.16 mV/m (70 dBμ) FM contour regardless of reserved band, non-reserved band or Translator designation; and the wording of the actual Schedule 340 "Diversity of Ownership" certification, which indicates use of the principal community (city grade) contour (which is nominally 70 dBμ for non-reserved band stations, 60 dBμ for reserved band stations and not-applicable for Translators). Therefore, out of an overabundance of caution, both the 70 dBμ and 60 dBμ contours have been employed for reserved band (NCE-FM) stations and Translators herein.
