Dear Licensee and Counsel,

We still have not received a response to our inquiry letter dated August 13, 2021 (see attached), nor has the station filed the silent STA that the licensee told Commission staff was forthcoming given the station's extended silence. A licensee is required under our rules to notify Commission staff if a station is silent for greater than 10 days and must file for silent authority if the station is going to be silent for greater than 30 days. A licensee is also required to provide a timely and complete reply to all Commission inquiries. The licensee is currently in violation of our rules and precedent. By this e-mail we are providing you one final opportunity to make the necessary filing and provide the requested information. **Failure to provide a written reply to our inquiry and file the required silent STA within the next seven**

days (no later than Tuesday, October 26, 2021), will result in sanction, including the possibility of forfeiture. We ask that you please reply to this e-mail with a courtesy copy of any application and written reply that is filed with the Commission.
