

## **Organization and Nonprofit Operation**

The Applicant was formed, under the laws of the State of Georgia, September 30, 2013 at a meeting of the membership where the Articles of Organization were drawn up and voted on to form the Company for the single purpose of filing for, building and operating a new station to serve the City of Pelham, Georgia as its first local aural assignment. By its Organizational Documents and bylaws the Company is required to operate non profit. All money that it may collect must go into the operation of the Pelham, Georgia station the Company operates. The Company has no paid Board Members, Officers, Members or Employees. Mitchell County Public Radio LLC owns no other business or broadcast interests and the Members of the Company holds no other broadcast interest. The company sells no advertising and operates solely on the donations of its Members.

The Certificate of Organization, herein attached, was issued by the Secretary of State's Office on October 18, 2013. Also attached is the Articles of Organization and current annual registration.

# **Articles of Organization of Mitchell County Public Radio LLC**

## **Article I**

**The name of the limited liability company is Mitchell County Public Radio LLC.**

## **Article II**

**The limited liability company is formed to apply for, construct and operate an LPFM Broadcast Station to serve Mitchell County, Georgia. The company shall not engage in any other business. The company shall be non commercial and non profit.**

## **Article III**

**The organizing members of the company are: Cindy M. White, Jerry E. White, Donald E. White, and Donald F. White. After operations began, the company may from time to time solicit members from the Mitchell County, Georgia area to join the company and help in the operation of the radio station. The company will elect directors from the membership once every four years.**

## **Article IV**

**Seventy five percent of the board members of the Company must live within ten miles of the transmitter site of the proposed LPFM transmitter site at 2586 Old Pelham Road. No member may hold attributable interest in any other radio or television broadcast station license or construction permit.**

## **Article V**

**The station shall offer a variety of programming that is not currently available on the air in Mitchell County. The station will work with local schools, public and**


private as well as churches to make air time available for educational programming. The station will air local governmental meetings to keep the public up to date with matters of city and county government. The station will be a training tool for those in the community that wish to learn to produce educational and informative programming for radio. The station proposes to be a local radio access channel for the community.

#### Articles VI

The Registered Agent for the company shall be Jerry E. White. The physical Address of the Registered Office shall be 2586 Old Pelham Road, Pelham, Mitchell County, Georgia 31779. The mailing address shall be P. O. BOX 226, Pelham, Georgia.
