

# **CURRY COAST COMMUNITY RADIO BYLAWS**

## **ARTICLE I**

### **NAME**

#### **1.01 NAME**

The name of the Corporation is Curry Coast Community Radio, also referred to herein as CCCRadio.

## **ARTICLE II**

### **PURPOSES AND POWERS**

#### **2.01 NONPROFIT LEGAL STATUS**

CCCRadio is an Oregon non-profit public benefit corporation recognized by the State of Oregon.

#### **2.02 LIMITED TO EXEMPT PURPOSES**

This corporation is dedicated, organized and operated exclusively for charitable, scientific, literary, and educational purposes. Subject to the limitations stated herein and the Articles of Incorporation, the purposes of this corporation shall be to engage in any lawful activities, none of which are for profit, for which corporations may be organized under Chapter 65 of the Oregon Revised Statutes (or its corresponding future provisions) and Section 501(c)(3) of the Internal Revenue Code of 1954 (or its corresponding amended or future provisions).

#### **2.03 PURPOSE REGARDING LISTENER SUPPORTED NONCOMMERCIAL RADIO STATION**

CCCRadio is a non-profit corporation and shall be operated exclusively for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code.

CCCRadio is an educational nonprofit organization whose mission is to provide a powerful public forum, lending voice to local cultures, art, education, entertainment and government working together to bring peace, justice, harmony, and prosperity to all people of Curry County, Oregon. As it carries out this mission, CCCRadio will embrace our community and

encourage people from all walks of life to collaborate in making this low power FM (LPFM) radio station a successful community endeavor.

CCCRadio's programming will have a common theme of educational enhancement, growth and community action. The Curry Coast, as a whole, will benefit from the unique educational and entertainment opportunities offered through CCCRadio broadcasts. To fulfill the educational programming mission of this LPFM radio station, CCCRadio will rely on a plethora of minds, talents, and ideas that the unique populace of Curry County, Oregon, has to offer.

- Curry County, Oregon, has activities that focus on a diversified collection of science, literature, art, music, and stage. CCCRadio will target this blend of local talent by broadcasting programs that showcase these gifts.
- Curry County, Oregon, residents will gain valuable verbal, organizational, structural, developmental, and technical skills by aiding in the production process of CCCRadio's programming and broadcasts.
- Curry County, Oregon, students at all grade levels will be enriched by this opportunity to practice valuable skills in all aspects of radio station operation.
- Curry County, Oregon, is rich in green resources. Its unique natural environment blends ocean, waterways, and mountains into a never-ending array of geographical and ecological splendor. CCCRadio will promote environmental stewardship and economic development through programming to increase public understanding of our shared natural resources, including ways we can protect and develop these resources for the benefit of our community as a whole.
- CCCRadio will enrich the health and safety of Curry County citizens through broadcasts focusing on wellness and emergency preparedness.

## **2.04 POWERS**

The corporation shall have the power, directly or indirectly, alone or in conjunction or cooperation with others, to do any and all lawful acts which may be necessary or convenient to affect the charitable purposes for which the corporation is organized, and to aid or assist other organizations or persons whose activities further accomplish, foster, or attain such purposes. The powers of the corporation may include, but not be limited to, the acceptance of contributions from the public and private sectors, whether financial or in-kind contributions.
