

Eligibility Certifications

The Applicant is a Florida nonprofit corporation, as reflected in the corporation's 2021 Annual Report, included herewith. The Applicant is exempt from income tax under Section 501(a) of the Internal Revenue Code as an organization described in Section 501(c)(3).

The Commission has previously granted an Assignment Application in FCC File Number BALED-20200521AAN, which found the Applicant to be a noncommercial educational entity with a qualifying educational program. The Applicant will use the proposed station to advance the same educational program that the Commission approved in that previous application.

The Applicant intends to operate the station in the noncommercial mode with the following educational objectives:

1. To provide religious instruction and moral teaching.
2. To teach parents and children principles for strengthening the home.
3. To help members of the community discover solutions to the personal, social, relational, and health problems typical of contemporary times.
4. To provide for and to promote discussions of all areas of family, contemporary social, religious and personal life issues.
5. To teach the ideals of citizenship, integrity, personal responsibility, moral rectitude and spiritual maturity.

To further those educational objectives, the Applicant will present a variety of programming to inform, entertain, stimulate and educate the audience in Bay County, Florida, and the surrounding service area. The programming will be directed to listeners of all backgrounds and ages in an effort to instill a sense of harmony and cooperation among all members of the community.

Subject matter covered by programming will include spiritual growth, family development, community service, bridging denominations, education, and religion. Programs will be developed and selected so as to be responsive to the needs and interests in the station's service area.
