

Established Local Applicant and Diversity of Ownership Points

I, Norton William Smith, declare under penalty of perjury:

I am President, a board member and Pastor of Calvary Chapel Minot ("CCM"). CCM is the licensee of Low Power Station KFLK-LP, Minot, North Dakota, and an applicant for a new Noncommercial Educational ("NCE") station to be licensed to Minot, North Dakota.

I am knowledgeable regarding the history of CCM. On April 4, 2008, CCM was incorporated as a North Dakota nonprofit corporation under the name Minot Christian Fellowship. On September 13, 2010, the Articles of Incorporation were amended to change the name of the corporation to Calvary Chapel Minot.

Since its founding, CCM's church and headquarters have been located in Minot. The church, headquarters and the studios of KFLK-LP now are located at 4600 N. Broadway in Minot, the community of license of the proposed NCE station.


The fact the CCM has existed locally for many years is further confirmed by the fact that it has operated the studios of Station KFLK-LP from locations in Minot since the station first went on the air on or about March 18, 2015 (see BLL-20150318ABF).

Accordingly, CCM qualifies for Established Local Applicant credit.

CCM pledges to maintain localism characteristics during the period from the grant of the construction permit until the station has achieved at least four years of on-air operations.

Further, CCM pledges that it and any party to its application (a) will divest their interests in KFLK-LP upon commencement of operation of the full service NCE station for which CCM has applied (i.e., upon its filing of a license application and receipt of program test authority) and (b) will comply with the restrictions on station modifications and acquisitions, as defined in 47 CFR Section 73.7005, during the period from grant of the construction permit until the station has achieved at least four years of on-air operations.
