

ESTABLISHED LOCAL PRESENCE

The Applicant claims three points for having an established local presence in the proposed community of license, Baker City, Oregon.

The Applicant has operated an educational campus featuring an elementary school in Baker City, Oregon, at least since February 12, 1932. Attached are minutes from a meeting of the Conference's governing committee of that date indicating that an action was taken to appropriate funds to the "Baker school." The school is now known as the Baker City Adventist Christian School.

Additional historical record of the school is attached, consisting of the cover from a Daily Register and Scholarship Record used at the school during the 1945-1946 school year.

The Applicant has continued to operate this educational campus in Baker City continuously since 1932. The current address of the Baker City Adventist Christian School is 42171 Chico Road, Baker City, Oregon 98614. The geographic coordinates for this location are 44.79671, -117.84993. The reference coordinates for Baker City -- the proposed community of license -- are 44.774887, -117.831983. The distance between these two points is 1.74 miles. Accordingly, it is concluded that the applicant has established and maintained a presence within 25 miles of the reference coordinates of the community of license.
