

**EDUCATIONAL OBJECTIVES OF  
UPPER COLUMBIA MISSION SOCIETY OF  
SEVENTH-DAY ADVENTISTS**

The applicant is a nonprofit corporation organized under the laws of Washington in 1898. A copy of its Articles of Incorporation is attached. The Society operates primary and secondary schools throughout eastern Washington and northern Idaho.

The Applicant intends to broaden its education outreach to the broader community to school-age children, but also to people of all ages. Elements of this educational outreach will include the following:

1. School students will be involved in producing and recording programming.
2. Students will be invited to participate in studio tours and to learn how a radio station functions.
3. Programming will address local community social issues.
4. The station's airtime will be made available to local community leaders to explain and discuss their activities participation in the community.
5. The station will provide a medium for local community leaders to address social problems in the community and to present solutions.
6. The station will provide opportunities for and promote discussion of all areas of contemporary family, social, religious, and personal life issues.
7. The station will present programming to educate the community on the ideals of citizenship, integrity, personal responsibility,
8. The station will provide opportunity for, and promote discussion of, all areas of contemporary family, social, religious, and personal life issues.
9. The station will educate the audience about the ideals of good citizenship, principles of democracy, integrity, personal responsibility, and moral maturity.

Program content will be developed and selected so as+ to be responsive to the educational needs and interests in the proposed local community.

An agreement to form a corporation.

KNOW ALL MEN BY THESE PRESENTS: that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Washington, and to that end we do hereby certify,:

- First: That the name of said corporation shall be "UPPER COLUMBIA MISSION SOCIETY OF SEVENTH DAY ADVENTISTS".
- Second: Said copodation shall be located at College Place, Walla Walla County, State of Washington.
- Third: The objects of said corporation shall be the organization, establishment and maintainance of mission and church societies to teach, spread and promulgate the christian religion and morality in accordance with the teachings of the Seventh Day Adventists: ~~XXXX~~, and to erect and assist in erecting church edifices for such societies when established: and to build and assist in building structures for educational, charitable and benevolent purposes throughout eastern Oregon, Washington, Idaho and British Columbia and to said end to own, hold, mortgage, sell and convey property of every kind and description, and to do all other things incidental to the accomplishment of the above-said purposes.
- Fourth. Said corporation shall have no capital stock.
