- 6. The station will provide opportunities for and promote discussion of all areas of contemporary family, social, religious, and personal life issues.
- 7. The station will present programming to educate the community on the ideals of citizenship, integrity, personal responsibility,
- 8. The station will provide opportunity for, and promote discussion of, all areas of contemporary family, social, religious, and personal life issues.
- 9. The station will educate the audience about the ideals of good citizenship, principles of democracy, integrity, personal responsibility, and moral maturity.

Program content will be developed and selected so as+ to be responsive to the educational needs and interests in the proposed local community.

ARTICLES OF INCORPORATION UPPER COLUMBIA CORPORATION OF SEVENTH-DAY ADVENTISTS

To: Ralph Munro, the Secretary of State of the State of Washington:

The undersigned, <u>Donald G. Reynolds</u>, <u>President</u>, <u>and R. W. Heinrich</u>, <u>Secretary</u>, <u>for the purpose of forming a corporation under the non profit laws</u>, <u>RCW24.03</u>, of the State of Washington, state:

FIRST: That the name of this corporation shall be UPPER COLUMBIA CORPORATION OF SEVENTH-DAY ADVENTISTS.

SECOND: The term of existence is perpetual.

THIRD: The purposes for which the corporation is organized is as follows: to own and operate suitable and customary facilities for the purpose of public worship, religious training, and charitable activities under the supervision of the rules and discipline of the Seventh-day Adventist denomination.

FOURTH: As incidental to the main objects and purposes hereinbefore mentioned in Article THIRD hereof, the purposes for which this corporation is formed are as follows:

- 1. To own and operate schools for religious and/or secular training; to own and operate hospitals, orphanages, homes for retired and/or disabled members, youth camps and recreational centers, campgrounds, and auditoriums for religious convocations, and to carry on all other enterprises. and to own and operate establishments, book stores, and production and distribution units for religious aids, and to engage in the research, production, and sale of food products, the availability of which facilities would aid the practice of vegetarianism as advocated by the Seventh-day Adventist Church, all incidental to its primary purposes and in general to do whatever pertains to the interests, spiritual and/or temporal, of its members and/or of the churches and/or other institutions under its jurisdiction.
- 2. To issue annuities for the life or lives of the annuitant, or annuitants, and Trust Agreements under such conditions and upon such terms as it may hereafter adopt.
- To acquire, receive, and hold property, real, personal, and mixed, by contract, deed, conveyance, gift, bequest, devise, and/or by any and every other means by which property may be acquired, either for its own use or in trust, for religious, and/or charitable purposes,

and to invest and re-invest the same, and to sell, convey, administer, lease, deed, mortgage or otherwise dispose of the same, either absolute or for a term of years, or as security for loans or other indebtedness, or the performance of any other obligation. To borrow monies either secured or unsecured.

4. To do and perform any and all acts and things necessary or incidental to the objects and purposes hereinabove set forth, and to have and exercise all the powers now conferred, or which may be hereafter conferred by the laws of the State of Washington upon any corporation organized for purposes other than pecuniary profit, and to do any and all such acts and things, either alone or in connection with any other person, persons, corporation, and/or corporations.

FIFTH: The address of the initial registered office of the corporation shall be: S. 3715 Grove Road or P. O. Box 19039, Spokane, Washington 99219.

The name of the initial registered agent at that same address shall be: Donald L. Folkenberg .

EIGHTH: The property of this corporation is irrevocably dedicated to religious or charitable purposes, and upon the liquidation, dissolution, or abandonment of this corporation will not inure to the benefit of any

A Meeting of the members of said corporation having voting rights at which said Articles of Incorporation were adopted was held on May 26, 1981; a quorum was present at said meeting, and said Articles of Incorporation received all of the votes which members present at said meeting.
