

Kairos Broadcasting, LLC Amendment Exhibit KDLY/KOVE

Multiple Ownership Compliance: The proposed transaction involves an AM/FM combination in the same market. However, on August 11, 2021, Morcom Broadcasting, LLC filed an application for transfer of control seeking to transfer 85% of its membership interests to Kairos Broadcasting, LLC. See LMS File No. 0025961996. A multiple ownership showing demonstrating that common ownership of KDLY, KOVE and KTUG is permissible under 73.3555 of the Commission's Rules is attached.

Proposed Assignment of License to Fremont Broadcasting, Inc.

I am a Radio Consulting Engineer. My education and experience are a matter of record with the Federal Communications Commission. I have been authorized to prepare this statement and exhibits to review the purposed purchase for compliance with the multiple ownership rules. This statement and attached exhibits demonstrate full compliance with the Commission's Multiple Ownership rules.

There is mutual overlap of the principal community contours of proposed commonly owned stations. For FM stations, the principal community contour is the predicted 3.16 mV/m (70 dBu) contour. For AM stations, the principal community contour is the predicted daytime 5.0 mV/m groundwave contour computed in accordance with Section 73.183 of the FCC Rules.

The stations are not home to an Arbitron rated market.

Multiple Ownership Rules

Section 73.3555 of Commission's Rule and Regulations

(a)(1) Local radio ownership rule. A person or single entity (or entities under common control) may have a cognizable interest in licenses for AM or FM radio broadcast stations in accordance with the following limits:

(i) In a radio market with 45 or more full-power, commercial and noncommercial radio stations, not more than 8 commercial radio stations in total and not more than 5 commercial stations in the same service (AM or FM);

(ii) In a radio market with between 30 and 44 (inclusive) full-power, commercial and noncommercial radio stations, not more than 7 commercial radio stations in total and not more than 4 commercial stations in the same service (AM or FM);

(iii) In a radio market with between 15 and 29 (inclusive) full-power, commercial and noncommercial radio stations, not more than 6 commercial radio stations in total and not more than 4 commercial stations in the same service (AM or FM);

(iv) In a radio market with 14 or fewer full-power, commercial and noncommercial radio stations, not more than 5 commercial radio stations in total and not more than 3 commercial stations in the same service (AM or FM); provided, however, that no person or single entity (or entities under common control) may have a cognizable interest in more than 50% of the full-power, commercial and noncommercial radio stations in such market unless the combination of stations comprises not more than one AM and one FM station.

Radio Market Analysis

This analysis triggers one radio market of common contour overlap for consideration as a worst case. **See Figure 1.** The study will determine the number of AM and FM broadcast stations located in the competitive market as defined by the commonly owned radio stations.

To determine which stations are located in a given competitive market, the appropriate principal community coverage contours of all broadcast stations in the vicinity of the market must be calculated and a determination must be made if there is any overlap of these contours.

Market

The market is defined by the common overlap of **KDLY(FM)**, **KTUG(FM)** and **KOVE(AM)**; **(2) FM stations, (1) AM stations**. Figure 1 shows the three (3) commonly owned FM/AM stations that defined the radio market. It was determined that, in addition to the two (2) commonly owned FM stations and one (1) AM station, at a minimum ten (10) additional non-commonly owned FM stations overlap the defined radio market Figure 2.

None of the overlapping signals has a transmitter site more than 92 kilometers from the point of common overlap. None of these overlapping stations are owned by Fremont Broadcasting, Inc.

CONCLUSION

The proposed assignment is in compliance with the Commission's Multiple Ownership limits because the proponent will own only two (2) FM stations and one (1) AM station which will not represent control of more than 50% of the stations in the market. Specifically, in a radio market with 14 or fewer full-power, commercial and noncommercial radio stations, not more than 5 commercial radio stations in total and not more than 3 commercial stations in the same service (AM or FM); provided, however, that no person or single entity (or entities under common control) may have a cognizable interest in more than 50% of the full-power, commercial and noncommercial radio stations in such market unless the combination of stations comprises not more than one AM and one FM station.

Based on my analysis the proposed assignment is in compliance with the requirements of §73.3555. This statement and attached exhibit was prepared by me or under my direct supervision and is believed to be true and correct.

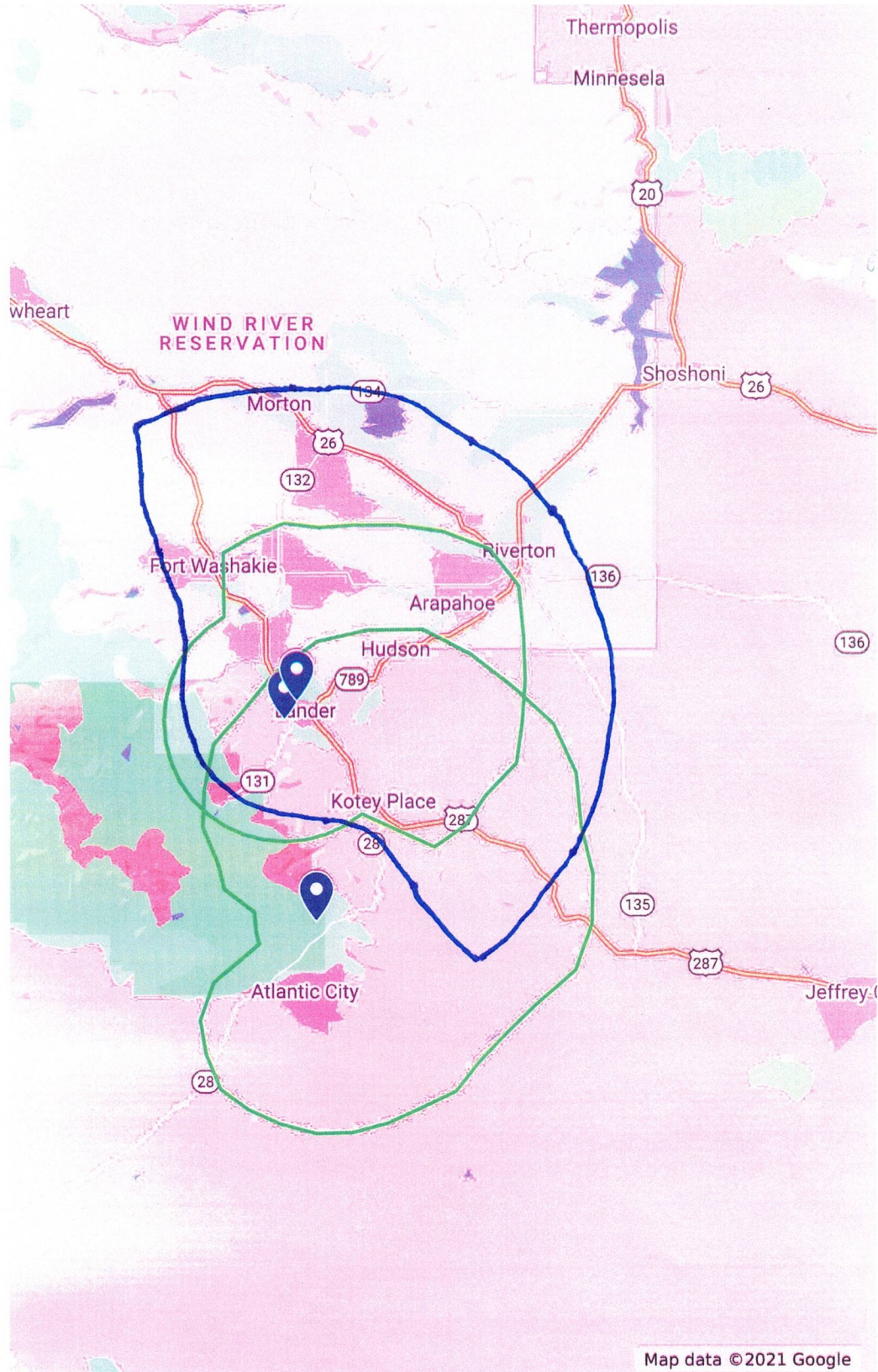
