

REQUEST FOR FURTHER EXTENSION OF SILENT STA

The Southern Oregon Conference Association of Seventh-day Adventists (“SOC”), licensee of low power television station KEVE-LD, Vancouver, Washington (Facility ID #67878) (the “Station”), hereby requests a further extension of the Special Temporary Authority to remain silent. Additional time is needed to complete the modifications occasioned by the television repack and to restore the station to service.

The Station has been silent since April 12, 2019, when it was required to vacate its channel in the course of the television repack. The subsequent history of SOC’s difficulties in completing the construction of the Station’s post-repack facilities are recounted in SOC’s previous requests to extend the STA granted in File Nos. 0000112398, 0000124748, and 0000144559. The Video Division granted these requests notwithstanding the 12 months of silence. The most recent extension expired on November 12, 2021.

During the most recent extension period, SOC has made substantial progress in its efforts to complete the modifications required by the repack and to return the Station to the air. All necessary equipment has been purchased and delivered to SOC. The transmission system was delivered on October 25, 2021. The antenna was delivered on November 3, 2021. RIO Tower & Steel, Ltd. has been contracted to install the antenna and cable on the tower. Installation on the tower is the only remaining unfinished business. SOC is awaiting the availability of the tower crew. In addition to crew availability, the tower installation is complicated by the need to coordinate the process with KATU, on whose tower SOC is renting space, as well as with other tenant stations on the tower. SOC expects to be able to complete the installation process prior to expiration of the station’s current construction permit on February 13, 2022.

Documentation of SOC’s dealings with equipment vendors and RIO Tower & Steel, Ltd. are attached.

After a difficult period of exceptional challenges to the completion of the modifications to the Station required by the repack process, SOC is now on the verge of resuming normal operation of the Station. SOC has expended considerable effort and resources to bring the restoration project to this point. The requested extension is justified in the interest of fairness and equity to the licensee. The extension would also serve the public interest in conserving a television service for the Portland, Oregon market.

The overall scope of the project is as follows:

- Mobilize crew to site.
- Offload and inventory materials.
- Rig tower.
- Remove existing antenna and mounts at 591' level.
- Assemble and install Dielectric DLP-12H slot antenna at 591' level, mounts included.
- Reconnect existing coax to new antenna.
- De-rig tower.
- Clean up site and remove job associated debris.
- Provide closeout package including photos.

Notes:

1. Clean graded and compact access for our equipment.
2. Bids are based on standard 40 hour work weeks.
3. This bid valid for 60 days from issuance.
4. Quote does not include sales tax.
5. All lighting and obstruction marking will not be modified.
6. Existing facilities will not be modified unless authorized and approved by tower owner.
7. RIO Steel & Tower, Ltd. and customer acknowledges that hoisting personnel may take place during the construction process. RIO Steel & Tower, Ltd. follows the American National Standard A10.48-2016 Section 8, and OSHA 1926.550 Current directive number CPL02-01-056 with regards to hoisting personnel. Stipulations:

1. Site accessible by Two-wheel drive work equipment and full sized Tractor- trailer rig
2. RF safe environment shall be provided for crew during normal working hours.
3. Free and clear accessibility will be provided for rigging at mounting height.
4. Night work is not included in this estimate. Night work, if needed will be based on time and materials only. (\$125.per man per hour)
5. Additional charge will apply if RIO must verify field dimensions prior to fabrication of materials.
6. Adverse weather conditions may affect installation and costs: Rain during installation will result in additional costs not to exceed \$2,000 per day, or delay of project until suitable weather conditions permit project completion within budget. In the event that more than 2 cumulative days is lost due to inclement weather the customer and the contractor will discuss options to either pay crew expenses or demobilize and remobilize the crew.
7. If there is any welding to be performed on this project and the size of the weld changes after the project was bid, there may be additional labor charged to cover the additional time.
8. Any additional work will be billed at the rate of \$105 / man / hour plus \$120 / man per diem and cost plus 15% on required materials. Work will be billed at time of approval by customer.
9. This estimate does not include any revisit for stoppage of work outside the original scope. A remobilization charge of \$2,500 for each visit will be assessed as well as \$2,000 a day for stand-by time.(i.e. missing or unavailable materials provided by others, delay in completion of PMI, CWI, pull testing, etc. provided by others, adverse weather, changes in scope of work.)
