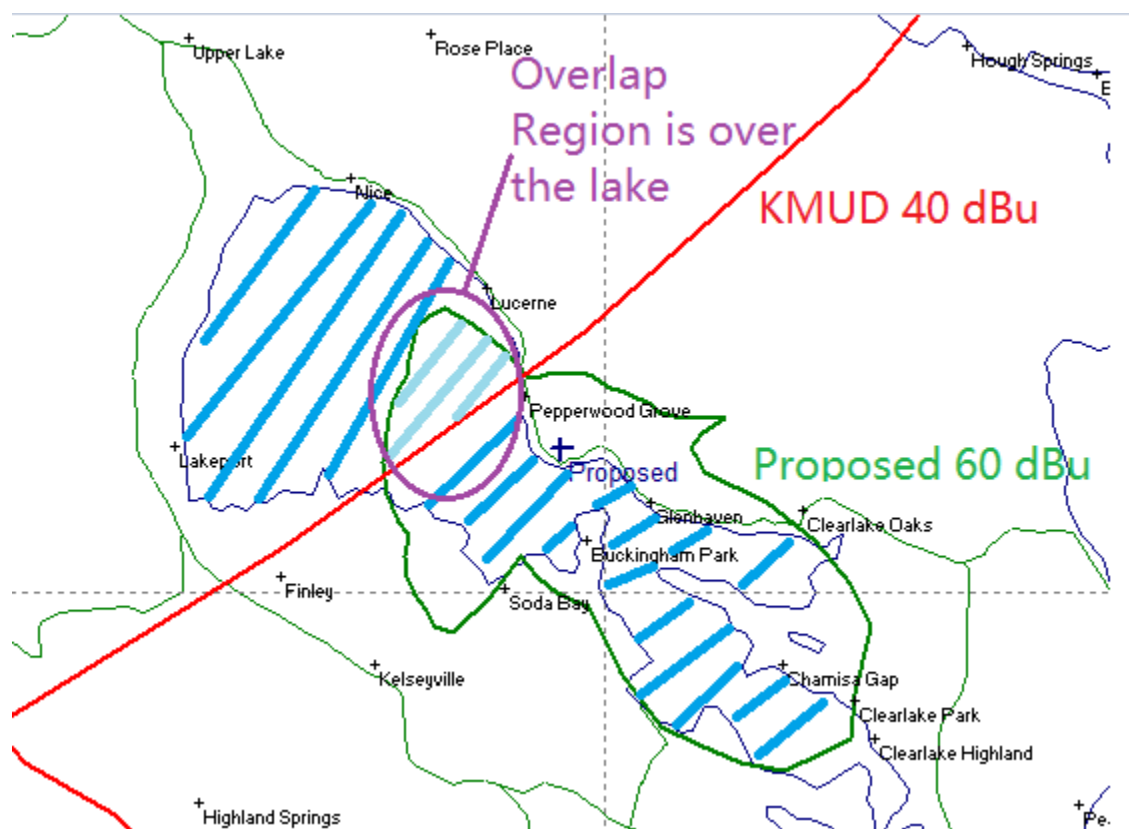

One Ministries, Inc. requests reinstatement of its application for new NCE station for Glenhaven, CA. This amendment resolves an issue Section 73.511(a) violation for not previously having a minimum Class A distance of 6 km. The proposed power level is now 100 watts. The antenna orientation has changed to be 140 degrees

There is contour overlap; however, the overlap is acceptable due to being over water. Furthermore, there is mountainous terrain shielding to KMUD Garberville channel 216, 143 km away. Please see map below demonstrating that the contour overlap region to KMUD's 40 dBu contour is over Clear Lake.
