

**Middle Georgia Community Radio
Pro Forma Transfer of Control Application**

Absence of Written Agreement

This pro forma involuntary transfer of control application relates to the death of Victor M. Vickers and the Probate Court's appointment of Becky A. Vickers as Executor of the Estate of Victor M. Vickers. A copy of the Probate Court's Letters of Administration is attached.

Originally Middle Georgia Community Radio was comprised of three equal equity owners – Victor Vickers, Richard Sasser and Vern Egli. However, prior to the death of Victor Vickers equity owners Richard Sasser and Vern Egli relinquished their equity interests in the company, although that was not reported to the FCC at that time. Accordingly, attached please find a consolidated letter from Richard Sasser and Vern Egli, recently executed, attesting to the fact that they long ago relinquished their equity interests in Middle Georgia Community Radio.






