

## **Renewal of License – TV Translator/LPTV Certifications, Discontinued Operations Narrative**

W35DQ-D initiated operations in Midland, MI, Facility: 184496, when it filed a license to cover application, FCC File Number: 0000008355, on 3/11/2016.

In addition to the periods of silence noted in the Adherence to Minimum Operating Schedule Narrative<sup>1</sup>, the station went silent on 6/11/2018 and a Silent Special Temporary Authority (“Silent STA”), FCC File Number: 0000055180, was filed 6/14/2018 and granted 6/14/2018. The reason for the period of silence was that the station was undertaking efforts to construct its permanent broadcast facility pursuant to the granted Displacement application, FCC File Number: 0000052690. Additionally, DTV America Corporation was operating in a resource-constrained environment due to the 600 MHz Incentive Auction repacking process. Station owners, particularly LPTV station owners which were deemed lower priority, that were seeking to build new broadcast facilities had access to far fewer resources such as tower crews and equipment than they would have had otherwise, a factor that the Commission and the Media Bureau acknowledged.<sup>2</sup>

The station filed an extension to the Silent STA, FCC File Number: 0000063999, on 12/5/2018 while it continued its efforts to construct its permanent displaced broadcast facility. The Licensee added new team members to facilitate the planning, design and construction of new facilities and diligently prepared site summaries and sketches, whilst completing the engineering design process and evaluating its Internet options for content delivery. The station was in contact with transmitter manufacturers and collecting quotes from vendors to complete construction.

The station duly filed a Section 312(g) waiver request on 6/11/2019, FCC File Number: 0000063999, as amended, which remains pending. The station resumed operations when it filed a License to Cover application on 6/14/2019, FCC File Number: 0000074730, which was granted on 7/26/2019.

The station went silent on 3/11/2020 and filed a Silent STA request, FCC File Number: 0000108136, on 3/17/2020.

The station resumed operations on 7/8/2020 and filed a Resumption of Operations, FCC File Number: 0000117539, on 7/10/2020. Since that date, the station has been operating pursuant to its authorized specifications.
