

### **§ 73.3555(a)(iii) Multiple Ownership**

Waco Entertainment Group, LLC. ("Waco") is the permittee/licensee of KLTO, Channel 256A, Moody, Texas (Facility ID# 198733). Waco herein is modifying KLTO and as such compliance with the Commission's Section 73.3555(a) Multiple Ownership Rules is required.

Waco is the licensee of KWOW Channel 281C2, Facility ID No. 6449, Clifton, TX and KWPW, Channel 300A, Facility ID No. 57377, Robinson, TX.

The principal owners of Waco also have an attributable interest in Prophecy Media Group, LLC, which is the licensee of KIXT, Channel 294C3, Facility ID No. 170995, Hewitt, TX.

A copy of the BIA FCC Geographic Market Definition Report for Waco, TX is attached as an Exhibit. Moody, Texas is located in McLennan County, which is part of the Waco, Texas Nielsen Radio Metro. In this Nielsen Radio Metro, including KLTO, there are 18 commercial and non commercial education full power radio stations.

§ 73.3555(a)(1)(iii) of the Commission's Multiple Ownership rules states; "in a radio market with between 15 and 29 (inclusive) full power, commercial and noncommercial radio stations, not more than 6 commercial radio stations in total and not more than 4 commercial stations in the same service (AM or FM)". Waco will have an attributable interest in four FM stations in the Waco, TX FCC Geographic Market. Therefore, it is believed that this FCC minor modification application for KLTO, Moody, Texas is in compliance with §73.3555(a)(1)(iii) of the rules.
