# ADDITIONAL INFORMATION IN SUPPORT OF APPLICATION FOR ATSC 3.0 AUTHORITY

This application proposes to convert LPTV station W25FK-D from ATSC 1.0 operation to ATSC 3.0 operation.

Under Section 74.782 of the Commission's Rules, simulcasting in both ATSC 1.0 and ATSC 3.0 formats is permissible, but not mandatory for LPTV stations. This application proposes transmission in only the ATSC 3.0 format, with no ATSC 1.0 simulcasting on any other station.

No change is proposed in the channel or any of the authorized licensed technical parameters for the station, except for a change in the ATSC signal format. Therefore, a construction permit is not required, and ATSC 3.0 authority may be granted directly on an application for modification of license.

Because no changes are proposed other than the ATSC format, there will be no loss in service area or population. There will be no simulcasting, hence there is no issue regarding overlapping signals from separate transmitter sites for ATSC 1.0 and ATSC 3.0 service.

In the absence of any site change or change in facilities, this application should be eligible for expedited processing under Section 74.782(g)(5) of the Rules.

**Amendment;** This is to advise that the licensee of W25FK-D will be operating the station in ATSC 3.0 without simulcasting as authorized by 47 CFR § 74.782(c) and will comply with the FCC requirements for such operation, 47 CFR 74.782. Notices to viewers was published in the Panama City News Hearld as required by Section 74.782(h) (see FCC 20-181, para. 39 and FN 131). Once this application is granted, the licensee will file to convert the license from ATSC 1.0 to ATSC 3.0. The station published the notice on 12/4/21 and ran it until 1/4/21.
