Construction Permit for Digital  
Low Power Television Station

Dear Permittee,

This concerns the construction permits and applications for extension of time filed by Landover 2, LLC to complete construction of the digital low power television stations listed in the attached Appendix. On March 25, 2021, we sent you a letter noting that we were unable to process the extensions and requesting additional information. We requested that you file the additional information in the form of an amendment to each extension. We noted that failure to submit this information within 30 days of the date of this letter will result in the dismissal of the extensions. We are not in receipt of amendments with the requested additional information.

In addition, Commission records indicate that construction of these facilities was not completed by the July 13, 2021 construction deadline. Pursuant to section 74.788(b) of the Commission's rules, any construction permit for which construction has not been completed shall be automatically forfeited upon expiration without any further affirmative cancellation by the Commission.<sup>1</sup>

Therefore, pursuant to 47 CFR § 73.3568(a), your applications **ARE DISMISSED** for failure to prosecute. Further, pursuant to 47 CFR § 74.788(b), the construction permits for these stations **HAVE BEEN AUTOMATICALLY FORFEITED** and the call signs **DELETED**.<sup>2</sup>
