Subject: Incorrect Call Signs on Consummation

Dear Mr. Colombo:

As you are aware, many of the FCC forms we file online with the FCC auto fill in the station data and will not allow the filer to alter them. This occurred on our recent Assignment or Transfer of Control applications. When the Assignment Authorizations were issued the call signs still did not match the Facility IDs (see attached Assignment Authorizations). Since the Facility IDs are correct, we are moving forward with filing the notice of consummation.

On the transfer from KTV Media, LLC to Pinnacle Media, LLC, the KPBI-CD call sign should be KWNL-CD to match the Facility ID of 52420 and the KQRY-LD call sign should be KXUN-LD to match the Facility ID of 14387.

On the transfer from Pinnacle Media, LLC to KTV Media, LLC the KWNLI-CD call sign should be KPBI-CD to match the Facility ID of 52426. The KQRY-LD information is correct.
