

MULTIPLE OWNERSHIP EXHIBIT

Under the Commission's local ownership "tiers" specified in Section 73.3555 of the Commission's rules, in a Metro reported by BIA as having between 15 and 29 full power commercial and noncommercial stations, a party may have a cognizable interest in up to 6 commercial stations, with not more than 4 stations being in the same service (AM or FM).

In the Grand Island-Kearney-Hastings, Nebraska BIA Metro Report, attached hereto, there are 24 full power stations.

Upon grant of this assignment application and consummation of the transactions contemplated herein, Flood Communications Tri-Cities, L.L.C. ("FCTC"), will have four (4) commercial stations, three (3) AM stations and one (1) FM station, in the Grand Island-Kearney-Hastings, Nebraska Metro Market: KICS (AM), Hastings, NE (Facility ID No. 26651), KHAS (AM), Hastings, NE (Facility ID No. 34487), KXPN (AM), Kearney, NE (Facility ID No. 52803), and KKPR-FM, Kearney, NE (Facility ID No. 52804).

A separate assignment application is being filed concurrently in which Flood Communications of Omaha, L.L.C. ("FCO") is acquiring Station KLIQ (FM), Hastings, NE (Facility ID No. 541), which is also part of the Grand Island-Kearney-Hastings, Nebraska Metro Market. FCO has no other stations in that market.

FCO shares certain attributable owners with FCTC. Thus KLIQ would be attributable to FCTC. But even with such the attribution, FCTC would comply with Section 73.3555(a)(1)(iii) of the Commission's Rules in that it would have attributable interests in only three (3) AM stations and (2) FM stations in the Grand Island-Kearney-Hastings, Nebraska Metro Market.

In addition, the proposed principal community contour of the stations referenced above do not overlap the principal community contour of any other full power commercial or noncommercial station that is (i) not located within or home to the Grand Island-Kearney-Hastings, Nebraska Metro market and (ii) is attributable to FCTC or any party to this application.
