

OTHER BROADCAST INTERESTS OF EDWARD R. STOLZ II

Edward Royce Stolz II is the sole member and owner of Royce International Broadcasting LLC, which is the parent corporation of Golden State Broadcasting LLC, Silver State Broadcasting LLC and Major Market Radio LLC.

Silver State Broadcasting LLC is the licensee of AM radio broadcast station KBET, Winchester, Nevada (FCC Facility ID 136292) and its associated FM translator station K267GX, North Las Vegas.

Silver Broadcasting LLC is also the beneficial owner of FM radio broadcast station KFRH, North Las Vegas (FCC Facility ID 19062), which was placed under the control of W. Lawrence Patrick as Receiver for the station (but not for Silver State Broadcasting LLC) per appointment by the United States District Court for the Central District of California, with the license having been assigned to the Receiver via a Form 316 application.

Golden State Broadcasting LLC is, likewise, the beneficial owner of FM radio broadcast station KREV, Alameda, California (FCC Facility ID 36029), subject to the assignment of the station license to W. Lawrence Patrick as Receiver for the station (but not for Golden State Broadcasting LLC) pursuant to a similar Form 316 application.

In addition, Major Market Radio LLC is the licensee of FM translator stations K238AK and K251BX, Palm Desert, California (FCC Facility IDs 147714 and 150925). Prior to Mr. Patrick's appointment, Major Market Radio LLC was also the licensee of FM radio broadcast station KRCK-FM, Mecca, California (FCC Facility ID 52808), and Major Market Radio LLC remains the beneficial owner of that station. (The license for KRCK-FM was assigned to Mr. Patrick via a Form 316 application similar to those described above for KREV and KFRH, but Mr. Patrick was not appointed as a Receiver over Major Market Radio LLC.)

On October 19, 2021, Golden State Broadcasting LLC, Silver State Broadcasting LLC, and Major Market Radio LLC filed petitions for protection under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the District of Nevada. The cases subsequently were consolidated. Under the Bankruptcy Code, property of the bankruptcy estates in the possession of a custodian like Mr. Patrick is to be turned over promptly to the debtor in possession promptly upon initiation of a Chapter 11 case. However, Mr. Patrick refused to cooperate in such a turnover. Consequently, the debtors in possession (Silver State, Golden State and MMR) moved the Court for an Order mandating the turnover. A hearing on the issue was held on December 21, 2021. On

January 31, 2022, the Court announced its grant of the Debtors' motion orally. On February 7, 2022, the Court issued an Order directing *inter alia* the turnover of the licenses for KRCK-FM, KREV and KFRH and any other property of the stations to the Chapter 11 debtor in possession entities corresponding to the above-referenced licensees. See, Bankruptcy Court Orders, Attachment to Assignor Legal Certifications Exhibit. Mr. Patrick is cooperating with the Court's Orders.
