

**APPLICATION FOR ATSC 3.0 LICENSE
KTVW LICENSE PARTNERSHIP, GP.
LICENSEE OF TELEVISION STATION KTVW-DT, PHOENIX, AZ,
FILE NUMBER BLCDT-20100818ABA**

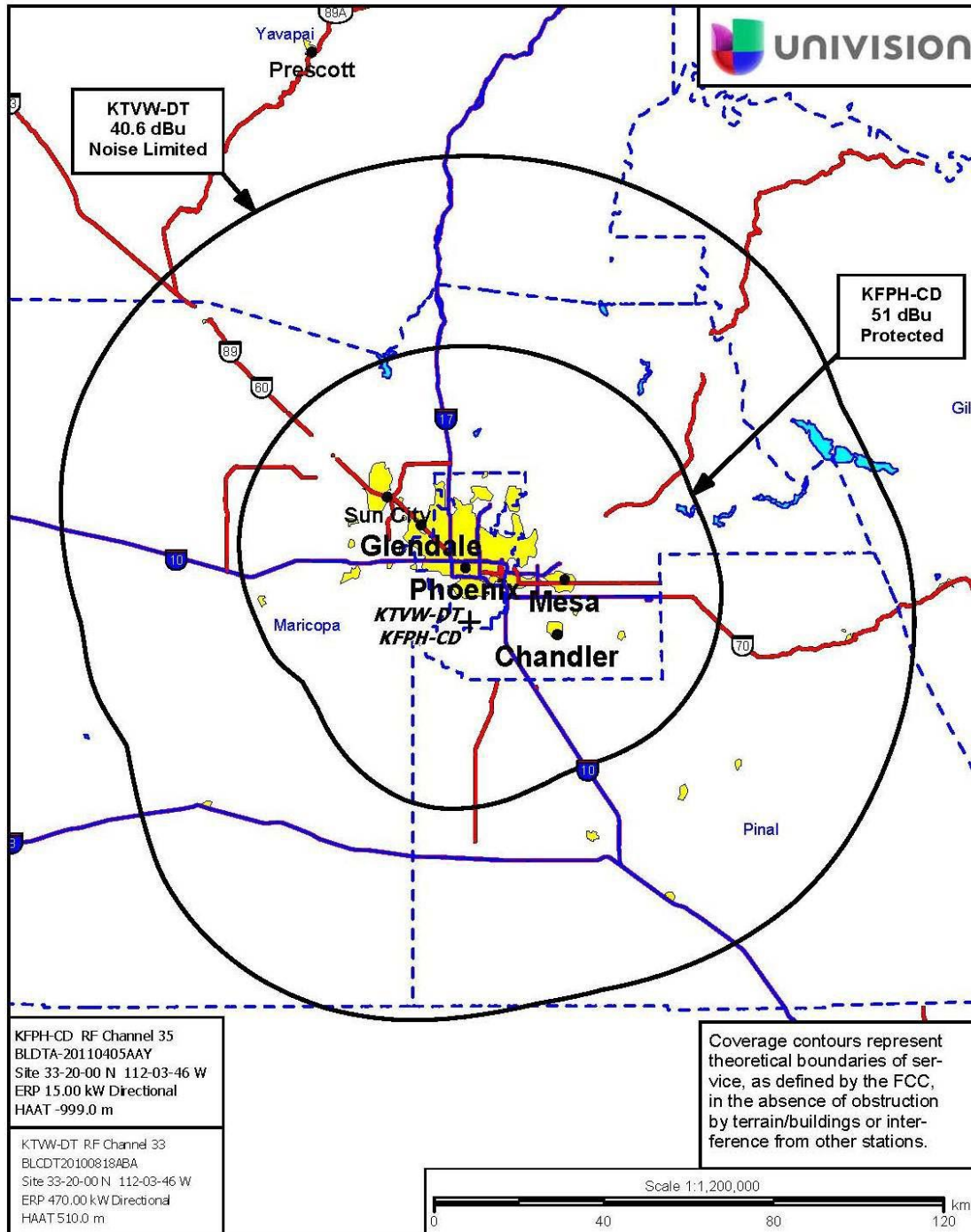
This exhibit supports an application by KTVW License Partnership GP, licensee of full power digital television station KTVW-DT, Phoenix, AZ, for modification of its licenses to reflect carriage in the ATSC 3.0 ("3.0") "Next generation" TV format on ATSC 3.0 "Lighthouse" station KFPH-CD, Phoenix, AZ, using KTVW's own call sign and PSIP.

KFPH-CD has been operating as an ATSC 3.0 Lighthouse station since March 29, 2018, initially under and experimental STA supporting 10 stations in the Phoenix Model Market and more recently as a licensed 3.0 station. Pursuant to its FCC authorization, KFPH-CD simulcasts its main .1 program stream in ATSC 1.0 on sister station KTVW-DT, Phoenix, Arizona.

Historically, KFPH-CD, an affiliate of the Unimas Network, has carried the signal of KTVW-DT as a multicast stream, to help ensure the greatest over the air availability of Univision Network programming in the Phoenix-Flagstaff market. This multicast carriage continued after grant of the experimental STA and after the Commission licensed KFPH-CD to operate in the ATSC 3.0 format, with KFPH-CD broadcasting the signal of KTVW-DT using that station's call sign and PSIP in ATSC 3.0. KTVW-DT files this application to memorialize this carriage.
