

**FURTHER AMENDMENT TO REQUEST FOR SILENT STA AND WAIVER OF SECTION 312(g)**

**March 17, 2022**

This Further Amendment responds to the request of Commission Staff for additional information/documentation on efforts made by Prime Time Christian Broadcasting Inc. (“PTCB”) to resolve technical difficulties and get their station KPCB-DT on the air.

The previously filed Request for Silent STA and Waiver of Section 312(g) discussed actions taken by the Station through January of 2021. Prime Time has searched its records again, and found additional documentation of visits by two vendors, on December 30, 2020, and January 20, 2021.

Shawn Percifield is an IT and networking professional. He went out to the Station transmitter site on December 30<sup>th</sup> to help set up the Dozer equipment when PTCB personnel couldn't get it to work. Attached is a text message from him from December 30<sup>th</sup>. He also remoted into the site a few additional times.

Matt Montgomery is an engineer. He went out to the site on January 20<sup>th</sup> to troubleshoot the black picture PTCB was getting from the Dozer box once the connection issue was fixed. Attached is a text message from him from that date.

At this time, PTCB cannot find any more written documentation for work done subsequent to January 20<sup>th</sup>. PTCB engaged Fletcher Heald & Hildreth in mid-February of 2021, and when Fletcher Heald advised PTCB of the need to file a Request for Silent STA and Section 312(g) Waiver, work at the site was generally terminated, pending resolution of the legal issues at the Commission.

At this time, PTCB anticipates that it will be able to resume broadcast operations on Station KPCB-DT within two days of grant of reinstatement and extension of the station’s license.






