

Consent Decree Compliance

Pursuant to Paragraph 21 of the Consent Decree (“Consent Decree”), dated March 7, 2022, by and between Lowcountry 34 Media, LLC (“Lowcountry”) and the FCC’s Media Bureau (DA 22-232, Acct. No. 202241420002, FRN 0027121466), Lowcountry hereby provides the following information pertinent to this instant minor modification application for low power television station W29EL-D, Lima, Ohio (Facility ID No. 187439) (“W29EL-D”):

1. **Purpose of the Application.** Lowcountry is filing this application at the request of W29EL-D’s proposed assignee, Metropolitan Indianapolis Public Media, Inc. (“MIPM”) (*See* LMS File No. 0000185528). MIPM is the licensee of noncommercial educational stations WFYI (PBS) and WFYI-FM (NPR). The application proposes to relocate W29EL-D’s antenna to MIPM’s tower, which will be the permanent site of the station’s antenna. Relocation of W29EL-D’s antenna to this site will facilitate the economical operation of the station – thereby avoiding any need for the non-profit assignee to pay tower rent to a third party. The application is being filed by Lowcountry before the closing of W29EL-D’s assignment to MIPM to permit the station’s relocation at the earliest date – thereby ensuring that W29EL-D will resume operation before August 3, 2022, the first anniversary of W29EL-D going silent (*See* LMS File No. 0000156252).
2. **Granted Minor Modification Applications.** W29EL-D been granted the following minor modification applications during the past 12 months:

3. **Rural Filing Window.** W29EL-D was originally authorized as part of the 2009 Rural LPTV Filing Window.
4. **Certification.** Attached hereto is a certification, signed under the penalty of perjury by Lowcountry’s Manager, Jeffrey Winemiller, demonstrating that Lowcountry intends to construct and operate a permanent facility for W29EL-D in a manner that is consistent with the Communications Laws (as that term is defined in the Consent Decree).
