Renewal Certifications

The station was the subject of a long-form transfer of control, which consummated on November 17, 2017. *See Entercom Communications and CBS Radio*, 32 FCC Rcd 9380 (MB 2017). In accordance with the Instructions to this Form 2100 – Schedule 303-S, the certifications made in this application cover only the period of time from and after such date.

FCC Violations

On July 22, 2020, the FCC's Media Bureau released an Order and related Consent Decree which settled and fully resolved matters involving Licensee's certain violations of the Political File Statute and Rule (as defined in the Consent Decree). *See FCC DA 20-775*.

Public Inspection File

As part of Licensee's internal public file review practices, as well as in connection with preparing to submit this license renewal application, Licensee discovered that certain documents, including those identified below, were either missing from the online public file or not uploaded in a timely manner.

All missing documents have since been uploaded to the public file. The missing and/or late documents included:

- **Political Files:** In certain instances, political file documentation may not have been immediately uploaded to the file. In addition, the invoices reflecting when certain political advertisements actually aired may not have been timely uploaded to the file.

The untimely political file uploads were fully resolved in connection with the Consent Decree described above.

The following documents were timely uploaded to the file, but then inadvertently deleted and reuploaded at a later date. As a result, the current time stamp for the following documents reflects the reupload date.

- **Quarterly Issues/Programs Reports:** As the screenshot below from the station's public inspection file history indicates, the Q1 2019 quarterly issues program report for KDKA-FM HD2 was timely uploaded to the file on April 1, 2019, but then inadvertently deleted and reuploaded on June 12, 2019.
