

**Certification Regarding Compliance with Section 73.3526 of the  
FCC's Rules During the Preceding License Term**

The Applicant acquired the station on January 8, 2016 pursuant to a long-form application on FCC Form 314, and its certifications only cover the period during which it has held the station's license. Upon review of its Public Inspection File to determine whether documentation required by Section 73.3526 of the FCC's Rules has been uploaded when required,<sup>1</sup> Applicant found that:

- While Applicant retains a list of all documents required to be disclosed under Section 73.3613 in its Public Inspection File, some documents were not added to the station's Section 73.3613 list (or, alternatively, uploaded) within 30 days after execution. An updated Section 73.3613 list was included in the station's most recent biennial ownership report.
- The Quarterly Issues and Programs List ("QIP") for Second Quarter 2017, due July 10, 2017, was uploaded on March 23, 2022. The QIP for Third Quarter 2017, due on October 10, 2017, was uploaded on January 8, 2018. The QIPs for Second, Third, and Fourth Quarters 2018 were uploaded on July 7, 2020. The QIPs for First Quarter 2018 and First, Second, Third, and Fourth Quarters 2019 were uploaded on July 8, 2020.
- The Commercial Limits Certification for Third Quarter 2017 was timely uploaded on October 9, 2017, but the list of programs designed for children 12 years of age and younger that aired during the quarter was uploaded on October 24, 2017. The Commercial Limits Certification for Fourth Quarter 2017 was timely uploaded on January 8, 2017, but omitted a list of programs designed for children 12 years of age or younger (the station has since uploaded an amended certificate).
- The Commercial Limits Certification for First Quarter 2016, due on April 11, 2016, was uploaded on July 12, 2020.
- The 2015-2016 Equal Employment Opportunity Report, due by April 1, 2016, was uploaded on June 10, 2016. (As noted above, the Applicant had only recently acquired the station in January 2016.) The 2016-2017 Equal Employment Opportunity Report, due by April 1, 2017, was uploaded on April 6, 2017.
- Some political file materials were not uploaded to the Public Inspection File within one business day of receiving the request for time.

Applicant will continue to remind station staff of Public Inspection file requirements and has provided, and will continue to provide, additional training to station staff and has worked to implement additional accountability procedures to enhance the station's compliance with Public Inspection File deadlines going forward.
