### **III. Foreign Ownership**

CMG and AGM are permitted to have foreign equity and voting interests up to and including 100%, subject to conditions to seek prior approval for any additional foreign investor that would acquire more than 5% of equity or voting rights.<sup>11</sup> Upon consummation of the long form transfer of control of the radio and television broadcast licensees controlled by AP IX (PMC) VoteCo LLC (including Broadcasting Licenses, the proposed assignee) resulting from the reorganization of AGM, the foreign ownership and voting rights in AGM is below the 25% benchmark set forth in Section 310(b)(4) of the Commission's rules, and BRH Holdings GP, Ltd. (a Cayman Islands entity through which AGM's principal shareholders had exercised joint control of AGM) has been removed from the AGM ownership chain as a result of AGM's reorganization.<sup>12</sup> Accordingly, Question Five under Assignee Alien Ownership is answered "No". Notwithstanding that the foreign ownership of CMG and AGM is presently less than 25%, CMG and AGM currently rely on, and will continue to rely on, the previously issued Declaratory Ruling permitting foreign ownership up to and including 100%.
