G.I.G., Inc., licensee of KCPM-LP, Fargo, ND (Facility ID No. 21187), submits the instant supplement to its April 6, 2022 submission. In this regard, in your letter of February 8, 2022, you made an inquiry concerning the operational status of KCPM-LP, Fargo, ND. Attached to this letter is an exhibit detailing the various submissions made to the Commission relative to the station's operational status (Attachment A). It should be noted that the former call letters for KCPM-LP were KVNJ-LP. In addition, until July 11, 2021, the station was broadcasting from the location specified in the attached Attachment B. On July 11, 2021, KCPM broadcast from the site identified in BLTVL-20020207AAQ.

At the present time, KCPM-LP, pursuant to your February 8, 2022 letter, is no longer broadcasting. Should the Commission so desire, G.I.G., Inc. is prepared to immediately request an STA to commence operation, but is reluctant to expend the requisite funds if the showing of operation is not deemed adequate.




