KNAZ-TV's Online Public Inspection File shows that the children's television programming reports for the 4th quarter 2014 through the 4th quarter 2015 were uploaded in 2018 and 2019. KNAZ-TV is a satellite of KPNX, Mesa, Arizona. It is the KPNX's policy to upload new and revised orders to its political file as soon as possible once an order or change has been accepted and processed. During periods of especially high activity, some political file updates may be delayed, particularly with respect to information revising ongoing orders or reconciling completed orders. Station personnel are available to answer questions from the public regarding any revision or reconciliation information not yet reflected in the station's political file. In connection with the preparation of this renewal application, the station reviewed a sampling of its current political file records. The station identified 19 orders placed in 2020 that were uploaded to the political file more than seven days after being placed. The station's review did not identify any orders placed in 2021 or 2022 that were not timely uploaded to the station's political file.
