Dear Permittee,

This concerns the above-referenced request for waiver (Request) of the Commission's tolling provisions and tolling of the Station's construction permit<sup>1</sup> for new low power television station K03ID-D, Flagstaff, Arizona (K03ID-D or Station).

In your Request, you point to an application for minor modification that you state has been pending since 2018.<sup>2</sup> You claim that you cannot construct the Station's facilities until the status of this application is resolved. On December 21, 2021, the Video Division of the Media Bureau dismissed this application.<sup>3</sup> Your petition for reconsideration of the dismissal was subsequently denied by the Media Bureau on June 8, 2022.<sup>4</sup>

The purpose of this letter is to afford you 30 days to amend your Request to either provide a detailed plan for construction of the Station under its current construction permit<sup>5</sup> or to file an application for minor modification that complies with the Commission's rules. You must also include a detailed plan for how you will complete construction of the Station within the extended time period. Please also include documentation to support your construction plan.

Please file the above-outlined information in the form of an amendment to the Request. Failure to submit this information within 30 days of the date of this letter will result in the dismissal of the Request.<sup>6</sup>
