I received your voice mail indicating that the KNNN-LP is not going to be able to resume operations with digital facilities (temporary or permanent) prior to its one-year silent anniversary. As such, you will need to file a request for extension of silent authority and include a request for reinstatement and extension of license under the equity and fairness provision of section 312(g). This is a very difficult task and I suggest hiring communications counsel to assist you with this filing **as the station's license is at stake**. You will need to show that "compelling circumstances" prevented you from resuming operations prior the one-year silent anniversary. This showing would be included with the silent STA extension.

There is also the matter of the station's pending request for waiver of the tolling rules. That request is insufficient. We will need to see the following before we can grant the tolling waiver.

1. A detailed accounting of all steps taken to complete construction since the grant of the previous tolling waiver including dates for each action and supporting documentation.
2. A detailed accounting of any and all circumstances outside of your control that prevented construction since the grant of the previous tolling waiver including dates of each circumstance and supporting documentation. Please describe how such circumstance(s) directly impacted construction.
3. A detailed accounting of what construction remains and a timeline plan of how and when you expect to complete construction and begin operations.

Note: **if the tolling waiver is denied, the digital CP will be cancelled along with the Station's license**. Again, I recommend having an attorney help you with this filing.
