

Request for Extension of Time for Submission of WTZP-LD's Eligible Invoices for Reimbursement

Eagle Broadcasting Group, Inc. (“licensee”), licensee of WTZP-LD, Portsmouth, Ohio (Facility ID 68009) (“WTZP”), respectfully seeks an extension to and including March 6, 2023, of its current September 6, 2022, deadline by which to submit all remaining invoices for reimbursement of eligible repack expenses from the TV Broadcaster Relocation Fund (“Fund”).¹ As discussed in greater detail below, an extension in this case would serve the public interest by addressing the fact-specific, unavoidable circumstances that have rendered it impossible for all reimbursable repack work for WTZP-LD to be completed and final invoices generated (and/or paid) by the current September 6, 2022, deadline.

As the Incentive Auction Task Force and Media Bureau (“IATF/MB”) have observed, limited extension of the September 6, 2022, invoice submission deadline for LPTV (and other) stations may be appropriate where there is “evidence that circumstances requiring the extension were outside of [the station’s] control”² In the case of WTZP, the licensee has diligently pursued construction of its authorized displacement facilities, as evidenced most clearly by the fact that post-displacement the station is and for some time has been on-air on its new channel providing service to the public. However, unanticipated circumstances caused the licensee to have to borrow and install interim equipment and operate WTZP at reduced power from authorized parameters—the licensee has been operating pursuant to STA since January 2022.³ See LMS File Nos. 0000178481 (January 2022 granted STA request for interim, reduced-power facilities while necessary tower reinforcements occur and replacement antenna was ordered), 0000195580 (extension of same STA). Unfortunately, due to supply-chain issues various equipment required to complete WTZP’s repack construction and resume full-power operation, including transmission line, transmitter, and antenna, cannot be received until October 2022. See **Exhibit A** (Dielectric letter, attached); **Exhibit B** (GatesAir letter, attached). That equipment is necessary for WTZP to continue to be able to deliver meaningful, community-focused programming, emergency alerts, and entertainment programming to the public in WTZP’s community of license and beyond.⁴

¹ The licensee respectfully submits that a modified March 6, 2023, deadline would not materially impact the Commission Staff’s need for sufficient processing time to complete close-out procedures for all remaining stations in the post-Auction reimbursement program. An LMS search conducted September 6, 2022, indicates that only approximately a few dozen Legal STA applications have been filed for TV translator / LPTV stations since July 1, 2022, meaning that only a small universe of reimbursement invoice submission extension requests have the potential to affect the processing time for close-out procedures. See the attached **Exhibit C**. To the extent FCC Staff disagrees with that assessment, the licensee respectfully requests an extension through whatever date would provide Commission Staff with sufficient processing time.

³ Prior to retaining current counsel, the licensee mistakenly filed an application for a license to cover its full displacement facilities instead of an STA for its interim, reduced-power operations. Compare LMS File No. 0000054002, with LMS File No. 0000074508. At the time of filing, the licensee believed that the license application was the filing necessary to cover its interim, reduced-power operations. WTZP is now operating pursuant to STA. See LMS File Nos. 0000178481, 0000195580.

Furthermore, WTZP is located on a tower owned by a third party—The Ohio State University (the “University”)—and under the terms of the tower lease WTZP is financially responsible for various remaining tower work that is required for WTZP to complete construction of its final displacement facilities. First, a Notice of Alteration must be (but has not yet been, to the licensee’s knowledge) filed with the FAA, as well as a subsequent update to the ASR to reflect the new FAA Air Study number that will be issued to cover the addition of WTZP’s final displacement facilities to the tower. *See* ASR No. 1027116 (currently covered by FAA Air Study 97-AGL-1456-OE). The University also has been investigating whether tower modifications relating to WTZP’s channel change would require, as a matter of Ohio state law, that the tower be brought into compliance with the latest ANSI standard. WTZP has on multiple occasions made the tower owner aware of the September 6, 2022, reimbursement invoice submission deadline, and in an effort to facilitate the University’s investigation, WTZP’s repack contractor has assisted with a structural tower analysis, guy line anchor evaluations, and other analyses of tower appurtenances. Ultimately, however, WTZP has no control over the University’s evaluation timeline or processes. Given the timing, any reimbursable components of the foregoing required work would necessarily occur after September 6, 2022.

Additionally, it bears noting that WTZP has consistently and regularly submitted invoices for eligible WTZP-LD repack services throughout the reimbursement period, as demonstrated by the nearly twenty Form 399 filings currently reflected in LMS. WTZP’s diligence in completing and filing those Forms 399 show both that (1) WTZP has not been a displacement or reimbursement laggard, but instead has consistently endeavored to move its repack project forward as expeditiously as reasonably practicable under the circumstances, and (2) WTZP is not requesting this extension of time with the intent of filing numerous Forms 399 or numerous invoices covering reimbursement expenses that have already been incurred. To the contrary, this extension request primarily relates to invoices for work that has not yet been performed and could not have been performed earlier given the circumstances and timing constraints noted above.

The facts and circumstances here relating to WTZP’s inability to incur all reimbursement-related expenses prior to the September 6 deadline are similar to many of the factors IATF/MB routinely considered relevant to repack construction permit extension requests. *See, e.g., Incentive Auction Task Force and Media Bureau Remind Repacked Stations of Certain Post-Auction Transition Requirements and Deadlines*, Public Notice, 33 FCC Rcd 8240, at ¶ 12 (IATF/MB Aug. 2018) (citing among circumstances relevant to consideration of construction permit extension requests “delays in construction due to the unavailability of equipment or a tower crew,” “tower lease disputes,” “unusual technical challenges,” or “delays caused by the need to obtain government approvals, such as land use or zoning approvals” for the work to be performed).

Because of the foregoing unusual and exceptional circumstances beyond WTZP’s control, a grant of a limited extension to March 6, 2023, of the deadline for WTZP to submit its final repack-related invoices for reimbursement is warranted, does not contravene the public

interest, and should not result in an additional burden to any other party, including the Fund Administrator, the Commission, and other stations seeking reimbursement for eligible transition-related costs.

Dielectric Letter and Email Exchange Regarding Supply Chain Delays

Dear Kim,

I am writing to provide some context behind the material delays specific to foam dielectric, elliptical waveguide and broadcast air dielectric cables. Covid-19 has created myriad supply chain issues, and this is having an impact from harvesting raw materials (labor), multiple steps of transport, and bottlenecks with the few global manufacturers of copper strip.

In RF copper cables, foam dielectric, air dielectric and elliptical waveguide, all are made from pure copper, which is formed into round or oval-shaped conductors and then corrugated. In all cases, this conductor is formed from a flat copper strip that has to be made to an extremely consistent thickness, and of very high purity. This product is made by few, highly specialized companies.

Multiple aspects of the global supply chain have had an impact on production and lead times. Starting with mining the copper ore from the ground, which has been hampered with labor shortages created by covid which has limited workforce output. Most steps in harvesting and processing occur outside the United States, and each stop along the way has been adversely impacted. While many people have been hearing about container costs rising, container availability has also been a major problem.

We work diligently with Commscope on a daily basis, trying to secure valid lead time and availability information, working the best with the information which is provided to us.

Your Primus primary representative is kept up to speed on all information, and passes along all details on ship dates, availability, etc. to you as soon as he receives this.
