Please accept this document in response to the above-referenced matter regarding the operational status of FM translator station W221DG, Exton, Pennsylvania.

W221DG is currently in operation, and was in operation during portions of the period of interest between the dates of August 24, 2020 and August 25, 2021. During all periods of operation from the time of its construction through the present, W221DG has operated from its licensed location, with its authorized directional antenna pattern, at the authorized antenna height. All licensed parameters were maintained with the sole exception of effective radiated power which was purposefully reduced to eliminate interference to co-channel station WVLT, Vineland, NJ. Interference claimed by Clear Communications, the licensee of WVLT, and the correspondence exchanged is a matter of record with the Commission and is not duplicated herein. Despite W221DG complying with all applicable rule sections regarding interference in its application for construction permit and license, in part as a result of rule changes¹ that took effect during the period in question W221DG has been forced to operate at reduced power to avoid causing interference.

Footnote 3 of the letter received from the Commission requests a number of pieces of documentation and photographs which are included herein, however we believe that several requests for information are not applicable to the instant matter, including:

1. EAS log. FM translator stations are not required to maintain EAS equipment, nor EAS logs².
2. Payroll records. The licensee, Broadcast Sciences LLC, has not paid any employee to perform any services related to the operation of W221DG during the period in question. Any work performed was done solely by me, Jeffrey DePolo. I am the Managing Member and Sole Member of Broadcast Sciences LLC. I am not an employee, I do not draw a salary, nor have I taken any owner's draws from the company for any work associated with the station at any time during the period, nor at any time whatsoever.

3. Financial records. The only expenditures made related to the operation of the station during the period were lease payments to American Tower Corporation, the owner of the antenna structure, copies of which are included herein.

3/15/2021	Installation of lower-power transmitter (Bext LEX-100), station on air at reduced power, drive testing western Delaware County. Station taken off the air due to instability (spurious emission) noted when operating transmitter at reduced power level.
3/16/2021 – 7/9/2021	Station silent
7/10/2021	Installation of external attenuator, station on air for additional field testing
7/10/2021 – present	Station operating at reduced power, no reports of interference

We believe that perhaps there was a breakdown in communication between Broadcast Sciences as the licensee, Mr. Tannenwald's former law firm, and those in his firm appointed to handle his duties after his departure. If that is the case and prior attempts at communication by the Commission went unanswered, or if any notifications as to the status of the station and/or resumption of operations were not timely received by the Commission, we respectfully apologize.

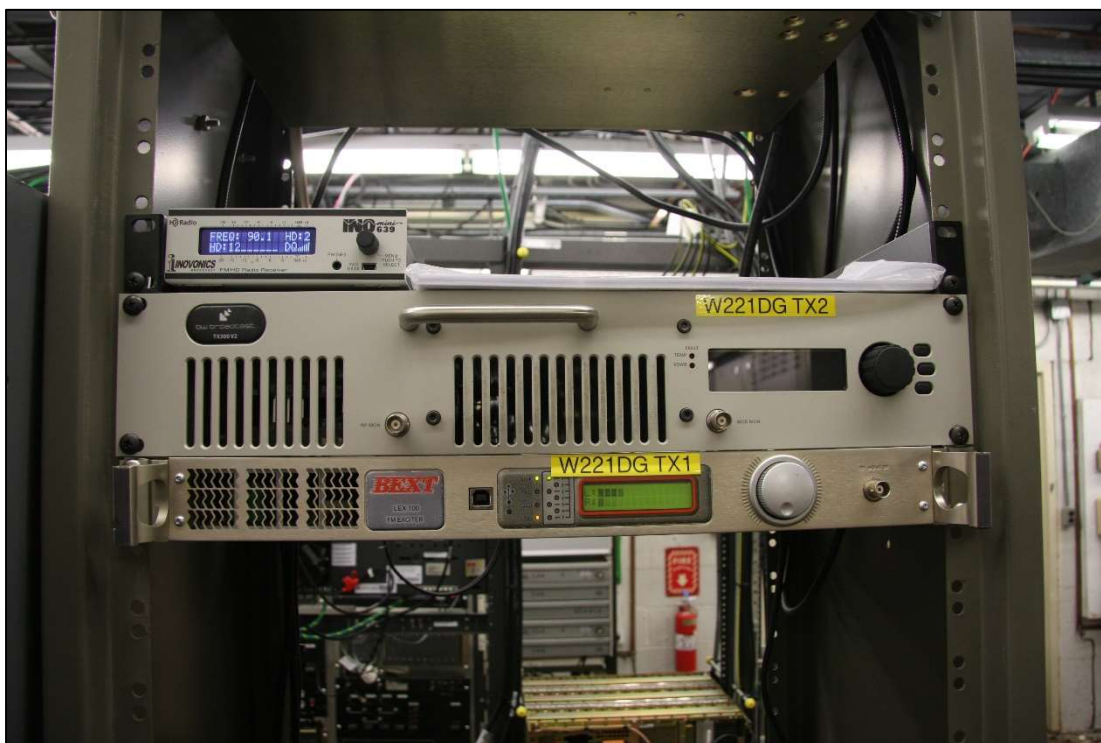

Transmitter building exterior with ASRN 1030858 posted (matches BLFT-20170106ACP)



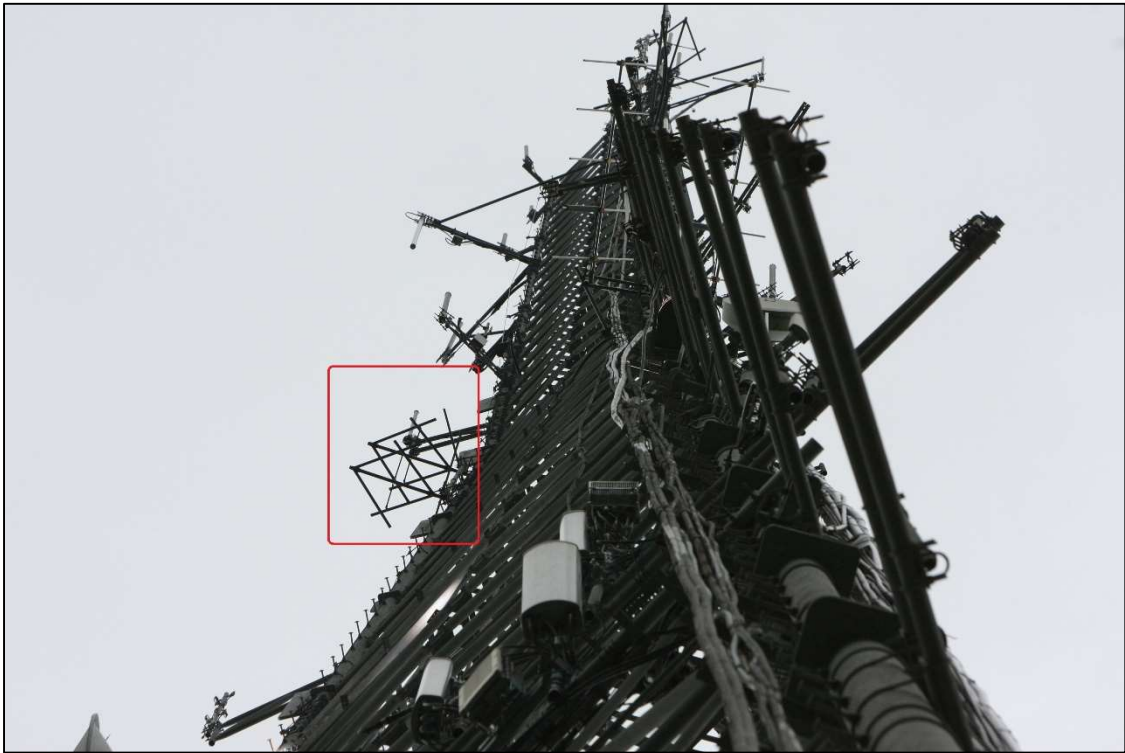
Structure owner's signage (ASRN matches BLFT-20170106ACP)



W221DG receiver and transmitters (TX1 in service)



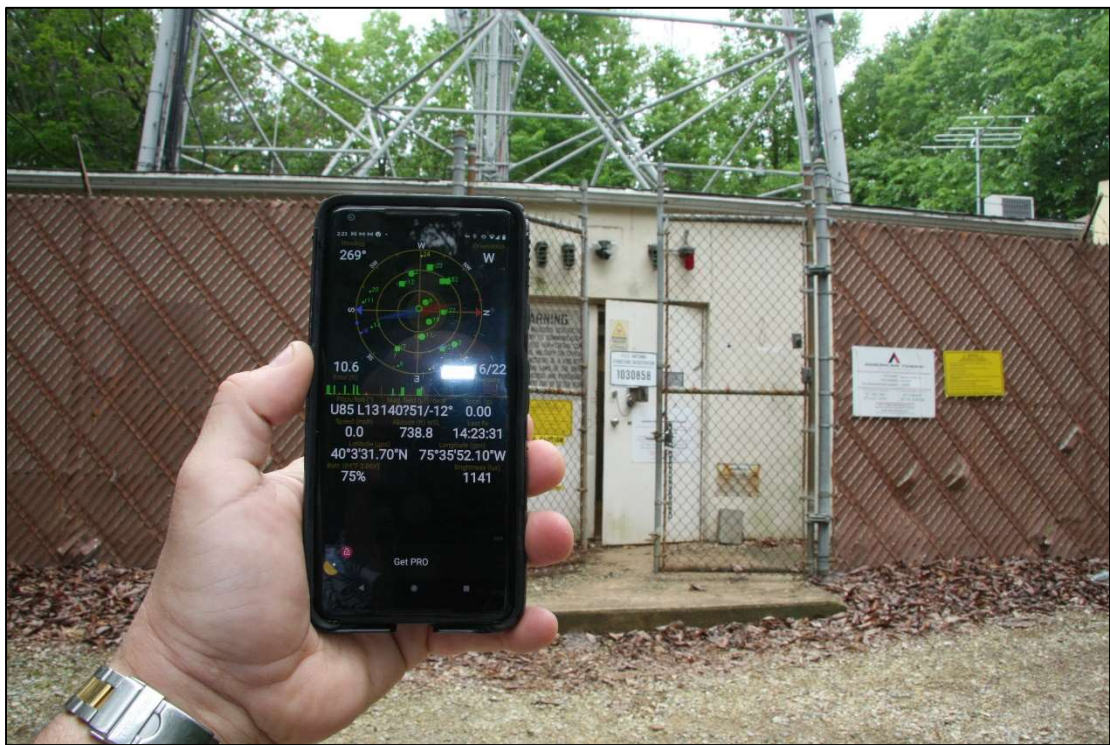
GPS coordinates in front of W221DG transmission equipment;

I am writing on behalf of Broadcast Sciences, LLC, in response to your attached letter of July 24, 2020, regarding FM translator station W221DG.

Broadcast Sciences, LLC, is owned by Mr. Jeffrey DePolo. He advised me this morning that he will be out of communication for an indefinite period of time and is not currently able to address the interference complaint.

He further advised me that he will attempt to take the translator off the air today and leave it off the air until he is able to return to work on the interference issue. I will work with him to request authority for the translator to remain silent. As long as the station is silent, it will not be able to cause interference to the signal of WVLT.
