

Description of Transaction and Parties to the Application

The majority of stock in the licensee, Woodward Communications, Inc. (WCI), is held by the Woodward Communications, Inc Employee Stock Ownership Trust (WCIESOT). Alerus Financial (Alerus) serves as the trustee of this directed trust. As WCI has represented to the Commission previously, the trustee is obligated to vote the shares of stock in WCI that are held by the WCIESOT in accordance with the instructions of a committee of WCI's board. Greg Bell, Sidney Scott, and Dennis Long have long served as the committee members. WCI intends to replace these three members with three new members who currently serve on WCI's board: James Etheredge, Mark Contreras, and Andrea Cunningham. This application seeks consent to the transfer of control from the current committee members to the new committee members.

With respect to foreign ownership, the WCIESOT is controlled by the committee members identified above who are, in turn, elected to those positions by the members of the WCI Board identified above. All are U.S. Citizens. This exhibit provides information pertaining to the structure of WCI when the new committee members are in place.
