

ASSET PURCHASE AGREEMENT

This ASSET PURCHASE AGREEMENT (this "Agreement") is effective as of September 2, 2022, by and between Jackson Hole Television, Inc. ("Seller") and International Spanish Network, L.L.C. ("Buyer").

RECITALS

1. Seller holds a Construction Permit (the "Permit") K24OE-D, pursuant to authorizations issued by the Federal Communications Commission (the "FCC"), as set forth in Exhibit A hereto (the "Authorization");
2. Seller desires to assign, and Buyer wishes to acquire the Permit for the price and on the terms and conditions set forth in this Agreement.

AGREEMENTS

In consideration of the above recitals and of the mutual agreements contained in this Agreement, Buyer, and Seller, intending to be bound legally, agree as follows:

1. Purchase Price: The Purchase Price for the Permit shall be Eight Hundred and Fifty Thousand (\$850,000.00) Dollars consisting of conditions and terms agreed upon by both Seller and Buyer.
2. Non-Refundable Deposit: Upon executing this Agreement and filing the Assignment Application (FCC Form 314). The Buyer shall deposit Twenty-Five Thousand Dollars (\$25,000) in the Seller's account.
3. Assignment and Assumption: Buyer shall not assume any liabilities and obligations of Seller if any.
4. Closing: Closing is to take place within ten days of initial FCC approval, as long as no protests have been filed with the FCC.
5. Consummation: The Seller shall file the required consummation notice with the FCC within two (2) days after the Closing.
6. Other Contracts: Final contract for site tower, show concepts, talent (1099 Form) and can be signed by the Buyer after Closing. Seller will make best efforts to assist Buyer with contracts on the same terms and conditions discussed before Closing.
7. Further Assurances. The parties shall take any actions and execute any other documents that may be necessary or desirable to the implementation of the approval of the Federal Communication Commission ("FCC") with the filing of the consummation notice of this Agreement within two (2) days of FCC's initial approval.
8. Governing Law. This Agreement shall be governed, construed, and enforced in accordance with the laws of the State of Wyoming (without regard to the choice of law provisions thereof).

ASSET PURCHASE AGREEMENT

9. Counterparts. This Agreement may be signed in counterparts with the same effect as if the signature on each counterpart were upon the same instrument.

- This authorization is subject to the condition that low power television is a secondary service, and that low power television and television translator stations must not cause interference to the reception of existing or future full service television stations on either allotted NTSC or DTV channels, and must accept interference from such stations.

Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.
