Here is the explanation as to why the station is silent:

Carpenter Broadcasting, LLC recently acquired WZBY. The station was constructed by the prior owner in a remote area with equipment that has proved unreliable and subject to frequent operational outages. As the site is difficult to access by engineers for repairs, these outages were often prolonged. Rather than providing an unreliable service to the public, and establishing a bad reputation in the community, the new licensee has decided to rebuild the facility with more reliable equipment, and is currently working to that end. In the interim, the station is silent so that, when the new equipment is installed, the station can be introduced to the community as a reliable new source for local service.

Please let me know if you would like us to formally amend the STA or if you need any additional information.
