**Notification of License Cancellation**

Dear Licensee:

This letter is to inform you that the license renewal application of Station WRIA-LP, Jacksonville, Florida (Station),<sup>1</sup> licensed to SCLC Jacksonville Florida (SCLC) is dismissed for failure to respond to the Media Bureau's Letter of Inquiry,<sup>2</sup> and the license for the Station is cancelled.

As discussed in the *LOI*, the Bureau issued a *Memorandum Opinion and Order and Notice of Apparent Liability for Forfeiture (NAL)* that proposed a forfeiture of three thousand five hundred dollars (\$3,500) for failure to timely file a license renewal application and unauthorized operation of the Station.<sup>3</sup> Licensee did not respond to the *NAL*, but on October 5, 2021, we received correspondence from Dr. Shirley A. Watts that suggested that the Station was not operating and had not operated in years.<sup>4</sup> On November 17, 2022, we sent you the *LOI* investigating whether the Station was constructed and whether the Station has been silent for extended periods of time. SCLC was instructed to respond within 30 calendar days of the *LOI* and was warned that “[f]ailure to respond in full within the time period specified shall result in dismissal of the subject application for failure to respond to official

**correspondence pursuant to section 73.3568(a)(1) of the [FCC's] Rules.”**<sup>5</sup> As of today, no response has been received.<sup>6</sup> Accordingly, we dismiss the Application for failure to respond to the *LOI*.<sup>7</sup>

For the reasons set forth above, the license renewal application for Station WRIA-LP, Jacksonville, Florida (Application File No. 0000106586) IS DISMISSED.

The Commission's public and internal databases HAVE BEEN MODIFIED to indicate that the broadcast license for the Station is EXPIRED, that the Station's license is CANCELLED, and that the Station's call sign is DELETED.

Finally, we note that it is imperative to the safety of air navigation that any prescribed painting and illumination of the Station's tower be maintained until the tower is dismantled. Accordingly, the owner of the tower where the referenced Station's transmitting antenna is located is required to maintain the tower in the manner prescribed by our rules and the terms of the cancelled license.<sup>8</sup>
