Dear Mr Doak,

The KIMI tower has an ASRN of 1259292 but shows a structure height of 46m and the coordinates are off a little. The existing and proposed KIMI COR is 53m above ground which requires an overall tower height of 60m. We have learned that the tower owner listed on the ASRN no longer exists. The process for correcting the owner information along with the height and coordinates is not going to be a smooth process as it normally begins with the current owner. We are working along with our legal services on obtaining a corrected ASRN. I will let you know when we have a solution and appreciate your patience.

Hello:

This is regarding Application File Number 0000149924 for KIMI(FM), Malvern, Iowa, Fac ID No. 189501. In the application it is stated that the proposal does not have an FCC antenna structure registration number (ASRN). However, the proposal has been filed with the FAA (Study No. 2020-ACE-6325-OE). Because the proposal has been filed with the FAA and because of objections by the FAA to similar proposals, the proposed tower must be registered with the FCC.

Please note, the following discrepancies between the FCC application and the FAA study must be resolved by either amending the FCC application or amending the FAA study.

Coordinates

FCC application: 40 56 56.3 NL, 95 45 29.1 WL

FAA study (nearest tenth): 40 56 56.4 NL, 95 45 29.2 WL

Site elevation

FCC application: 390 meters

FAA study: 391.7 meters
