

## Notification of Change in Primary Station

Hope Media Group (“HMG”), licensee of FM translator station W212CG, West Palm Beach, Florida (Facility ID No. 123364), Channel 212/ 90.3 MHz (“W212CG”), hereby notifies the Commission that W212CG’s primary station has now changed to noncommercial FM broadcast station WAYF, West Palm Beach, Florida (Facility ID No. 61507), Channel 201/ 88.1 MHz (“WAYF”). In support of this Primary Station Change Notification, HMG provides the following information:

1. **Primary Station Change is for a Licensed Translator Facility.** HMG certifies that this Primary Station Change Notification applies to W212CG, which is a licensed translator facility. *See* CDBS File No. BLFT-20190325AAI (granted Mar. 27, 2019).

2. **Scope of Primary Station Change Notification.** HMG certifies that this Primary Station Change Notification applies to W212CG’s currently licensed facilities.

3. **Contour Exhibit.** Attached hereto is a contour map (“Contour Exhibit”) depicting the protected contours of both W212CG and WAYF. As WAYF operates in the reserved band, WAYF’s 60 dB $\mu$  contour is used in the Contour Exhibit.

4. **Fill-In or Non-Fill-In Service.** As demonstrated by the Contour Exhibit, W212CG provides permissible fill in service for its primary station, WAYF in accordance with Section 74.1201(g) of the Commission’s rules (47 C.F.R. § 74.1201(g)) as W212CG’s coverage contour is wholly within WAYF’s service contour.


5. **Primary Station Stream Being Rebroadcast.** W212CG rebroadcasts WAYF’s HD2 signal.

6. **Method of Signal Delivery.** WAYF’s signal is delivered via the Internet to W212CG in accordance with Section 74.1231(b) of the Commission’s rules. 47 C.F.R. § 74.1231(b).

7. **Rebroadcast Consent.** As HMG is the licensee of both WAYF and W212CG, no express written consent is necessary for W212CG to rebroadcast WAYF’s signal. Moreover, HMG’s common ownership of WAYF and W212CG is permissible pursuant to the Commission’s rules.

9. **Compliance with Section 74.1232(d).** Furthermore, W212CG’s rebroadcast of WAYF’s signal complies with Section 74.1232(d) of the Commission’s rules (47 C.F.R. § 74.1232(d)) because: (a) W212CG is providing permissible fill-in service for WAYF as discussed above; (b) HMG is the licensee of both WAYF and W212CG and is therefore presumed to have authorization to rebroadcast WAYF’s signal on W212CG; and (c) W212CG was originally authorized by a license or construction permit in effect as of May 1, 2009. *See* CDBS File No. BNPFT-20000515ABD (granted May 19, 2000).
